APPROVAL OF MINUTES

Rebecca Broussard made a motion to approve the minutes and Dawson Primes seconded the motion. There was no opposition. The June 2018 minutes were approved.

GOHSEP UPDATES

Casey Tingle

- Presented an overview of GOHSEP's reorganization
 - o GOHSEP's FY2018/2019 budget appropriation included two new positions.
 - Regional Coordinators now will report to the Executive Office. The Coordinators will continue to report the Darren Guidry (Section Chief) and Darren will report to Casey Tingle (Chief of Staff).
 - A Homeland Security and Interoperability Division was added.
 - The renamed Emergency Management Division includes a new branch of Community Preparedness, which includes the two new positions. Long Term Recovery will fall under this branch.
 - o GOHSEP will notify all Parish OHSEP Directors of the recent changes.
- GOHSEP will hold a Leadership Workshop for our agency supervisors and management at JSETC on September 18th and 19th and we are seeking a Parish OHSEP Director to participate on a panel discussion,
- The Governor issued an Executive Order setting up a Watershed Council that includes GOHSEP, OCD, CPRA, Wildlife & Fisheries and DOTD. The council will

- make a recommendation for the Governor on how to allocate \$1.2 billion in CDBG Mitigation Funds. The funds have been passed by Congress but HUD has not released funding to the State.
- The council is going to be starting a fall engagement across the State to elected
 officials and citizens. Information will be sent out on the meetings. The meetings
 will be open to the public.
- October 1st is the deadline for GOHSEP to make any recommendations to the Governor's Office for legislation requirements for the next regular session. GOHSEP is working on the current Budget Request for next July.
- We are still waiting on FEMA Headquarters to respond officially to the Governor request for the Spring River Flooding Declaration.
- GOHSEP will include a request to fully fund all SIEC approved new tower sites for LWIN as part of our FY 2019/2020 budget request.
