1. The meeting was called to order at 10:08 am.
2. **Roll Call:** A quorum was confirmed.
3. **Consideration: Approval of Minutes**

Chairman Daniels stated that in the next 6-12 months the RTA has to make some tough decisions and he appreciates the leadership of the team.

Sundiata Haley stated that there is an Executive Session
7. **Consideration: RTA's Chief Executive Officer's Report**  
The CEO stated that the most important thing is the safety of staff and their families and plexiglass was installed behind the operators on buses and the buses and streetcars were being disinfected on a regular basis.

The CEO stated that 75 employees tested positive for COVID-19.

**CARES Act**

- Utilizing \$43M in funding made available through the CARES Act, the RTA may be able to cover operating costs for the next 6-9 months. Additionally, an agreement has been reached between the RTA and its contracted transit operators—Transdev and LabMar Ferry Services, which will provide for **80**

**hours of paid COVID-19 related administrative leave to all employees affected by this crisis.**

Chairman Daniels stated that all passengers should have a face-covering to ride the system. Any type of face-covering will be acceptable and if passengers don't have face coverings the operators will provide one.

**8. Consideration: Advertising Policy**

- The CEO stated that RTA's Advertising Policy need to fit the Best Practices of the Industry and currently the Advertising Policy brings in \$2 Million.
- Commissioner Wegner stated that the RTA would lose money from Political and Religious Advertisement and she was concern about losing revenue at this time with COVID-19.
- The CEO stated that Councilperson Cyndi Nguyen had concerns with certain advertisements that was being placed on the buses.
- Commission Neal stated that these new rules would be applied to the Bus Shelters and the Ferries and the contractor would follow the new rules of the agency regarding advertisement.
- Commissioner Daniels stated that the RTA would not lose a significant amount of revenue by changing the Advertisement Policy.
- Alex Wiggins stated that this was not the final project that staff can work on all the concerns the Board had and can come back before the Board with any necessary revisions.

Commissioner Raymond moved and Commissioner Walton seconded to adopt this policy. Commissioner Wegner voted against the policy and Commissioner Tillery was absent from the meeting.

**9. Financial Statements – February 2020**

Mark Major stated that - Passenger Revenue – The fallout from the Hard Rock Hotel collapse continued to disrupt service, resulting in passenger fares and ridership dropping below projections in February by 14.8% and 13.4%, respectively

Mark Major stated that Services — Management Service Fees exceeded projections by 6.9% for the month, but lower than projected Professional/Technical Services through February (under 49%) created the positive variance for this expense category through the end of this reporting period. Almost every line item comprising Professional/Technical Services (i.e.,

Legal Fees, Consultants, Data Processing Services, etc.) was under budget through February.

Mark Major stated that - Materials and Supplies – Bio-diesel fuel prices slid by another \$0.25/gallon for the month, bringing it under budget by an average of \$0.63/gallon for the month and \$0.49/gallon year-to-date.

**10. 2020 Revised Budget**

**Total Operating Revenues**

- Approved CY2020 Operating Budget was \$107,299,007 – Revised CY2020 Projection \$58,423,150 and Total Projected CY2020 Operating Revenue Shortfall (\$48,875,857).

- Approved CY2020 Operating budget was \$109,348,372 – Revised CY2020 Projection \$109,367,060 and Total Projected Increase in CY2020 Operating Expenses \$18,689.

**Net Revenue (Expenses) After CARES Act Proceeds**

- CY2020 Budget was \$123,576 – Revised CY2020 Projection (\$4,919,324) and Variance \$43,851,645.
