

CERTIFICATION OF INABILITY TO OPERATE DUE TO LACK OF QUORUM

In accordance with Executive Proclamation JBE 2020-41, issued by Governor John Bel Edwards on April 2, 2020, the Louisiana Agricultural Finance Authority ("LAFA") is providing for attendance at an essential board or commission meetings via teleconference or video conference as allowed during the pendency of the COVID-19 health emergency.
