SPECIAL REQUESTS

- **Air Products and Chemicals, Inc. (Contract #20220395-ITE):**

Air Products and Chemicals, Inc. is requesting an amendment to its existing Exhibit A agreement to allow for a phased application as part of the planned project. At the time of submitting the initial application, the company understood the project end date to represent the beginning of operations for producing the product, rather than the date by which all assets would be fully operational and placed in service. As a result, the application was submitted on 11/18/2024 with an estimated project end date of 10/26/2024, along with confirmation that all property had been placed in service in 2024. The company is now requesting the ability to designate property placed in service in 2024 as Phase “A,” as the overall project is now expected to be completed in 2026.

From the Company:

“Air Products & Chemicals, Inc. (“Air Products”) entered in the above-mentioned Industrial Tax Exemption Contract with the State of Louisiana, effective December 31st, 2024.

Our Convent SMR Restart project consists of two major parts, the Steam Methane Reformer (“SMR”) and a Steam Turbine Generator (“STG”), for the project to be fully operational according to Advance Notification and Initial Application. While the SMR was completed in September 2024, the STG lagged substantially and is still not expected to be placed into service until March 2026. Initially, it was thought that the project’s end date (beginning of operation) had to be when the plant started producing hydrogen as opposed to when all assets were placed in service.

As a result, we have course-corrected and kindly request that the Board allow Phase Applications to be submitted as part of this contract to accommodate assets being placed in service in different calendar years. On behalf of Air Products, I would like to thank the Board for their time on this matter. It is always the goal to remain transparent, compliant, and always strive to do the right thing, so both Air Products and the great State of Louisiana can both benefit economically for years to come.”

SPECIAL REQUESTS (Continued)**● Cabot Corporation (Contract #20200327-ITE):**

Cabot Corporation is requesting to amend their existing Exhibit A agreement Sections 4.02(D) and 6.01(B)(1) to extend the commencement of operations and associated grace period from three years to four years to account for unforeseen delays.

From the Company:

"Cabot Corporation, Louisiana entered into the referenced Industrial Tax Exemption Contract with the State of Louisiana effective February 22, 2021. At the time of execution, the subsequent global COVID-19 pandemic and the resulting supply chain disruptions, material constraints, labor shortages, and related challenges could not reasonably have been anticipated. Many of these conditions have continued to impact project execution. In addition, the project has undergone a transition in contractors and internal project leadership to support continued execution and successful completion.

As a result, Cabot has exceeded the original planned Commencement of Operations date of June 30, 2023, as defined in Exhibit A, Section 4.02(A), and the two-year additional grace period provided under Section 6.01(B)(1). Cabot also appreciates the 2025 Special Request extension approval, ending June 30, 2026. Notwithstanding this accommodation, Cabot does not anticipate being fully operational by that milestone.

Accordingly, Cabot Corporation respectfully requests an amendment to Exhibit A, Sections 4.02(D) and 6.01(B)(1), to revise the referenced period from "three" years to "four" years. This amendment would extend the commencement of operations and the associated grace period and adjust the applicable Project Years accordingly.

Cabot Corporation has continued to proceed with commercially reasonable due diligence on this project and remains committed to its completion. With the requested extension, Cabot fully expects to meet or exceed the Project Estimated Investment Valuation (\$109,731,690), New Net Jobs Creation (15), Required Annual Payroll (\$1,095,000) as contemplated under the Agreement."
