Request that the Board reconsider its decision to decline to waive the \$1,000 campaign finance late fee assessed against Christopher Williams, an unsuccessful candidate for Sheriff, Orleans Parish, in the November 13, 2021 election, whose 2021 campaign finance disclosure report was filed 10 days late.
