3. **L15-029 - Allen Parish Police Jury - (1) Road District No. 1 - 22.03 mills tax, 10 years, 2016-2025, constructing, improving, operating, and maintaining Parish roads and bridges; (2) Road District No. 1, Sub-Road District No. 1 - 8.03 mills tax, 10 years, 2016-2025, constructing, operating, and maintaining Parish roads and bridges; (3) Road District No. 3 - 35.79 mills tax, 10 years, 2016-2025, constructing, improving, operating, and maintaining Parish roads and bridges; (4) Road District No. 4 - 30.19 mills tax, 10 years, 2016-2025, constructing, operating, and maintaining Parish roads and bridges; (5) Road District No. 4 - 21.14 mills tax, 10 years, 2016-2025, constructing, improving, operating, and maintaining Parish roads and bridges; (6) Sub-Road District No. 5A - 2.79 mills tax, 10 years, 2016-2025, constructing, operating, and maintaining Parish roads and bridges.**

6. **L15-022 - Claiborne Parish Police Jury - ½% sales tax, 10 years, May 1, 2015 - April 30, 2025, operation, maintenance and improvement of hospital facilities and equipment for the Claiborne Memorial Medical Center (formerly known as the Homer Memorial Hospital), pursuant to an Intergovernmental Agreement.**
7. **L15-026 - DeSoto Parish School Board - (1) 8.17 mills tax, 10 years, 2017-2026, operation and maintenance of the public elementary and secondary schools; (2) 43.17 mills tax, 10 years, 2017-2026, (a) maintaining and operating school facilities, including insurance and utilities with respect to the facilities and (b) salaries of teachers and other school personnel.**
8. **L15-009 - East Baton Rouge Parish, Zachary Community School Board, Zachary Community School System - 1% sales tax, 10 years, beginning July 1, 2015, any lawful school purposes, including payment of salaries and benefits of teachers and other school system personnel.**
9. **L15-001 - Jackson Parish, Hodge Fire Protection District No. 1 - \$72.00 parcel fee, 10 years, 2016-2025, (1) acquiring, constructing, maintaining and operating fire protection facilities and equipment, including cost of obtaining water and salaries and (2) all purposes incidental.**
10. **L15-014 - Jefferson Parish, City of Harahan - 5.0 mills tax, 10 years, 2015-2024, constructing, acquiring, maintaining and operating the City's fire protection facilities and equipment, including payment of salaries, insurance and other expenses of the Fire Department.**

14. **L15-002 - Ouachita Parish, East Ouachita Recreation District No. 1** - 7.5 mills tax, 10 years, 2016-2025, constructing, improving, maintaining, operating and equipping the recreational facilities.
15. **L15-024 - Ouachita Parish School Board, West Ouachita School District** - 1% sales tax, to be levied in perpetuity, beginning January 1, 2025, (1) constructing, acquiring, improving, equipping, furnishing, maintaining and/or operating schools and school related facilities and (2) funding into bonds.
16. **L15-005 - Sabine Parish Police Jury - (1) Road District No. 1, Ward 6** - 16.65 mills tax, 10 years, 2017-2026, constructing, improving, maintaining and/or repairing public roads and bridges, including ditching and drainage and purchasing of equipment; (2) **Road District No. 15, Ward 5** - 13.02 mills tax, 10 years, 2017-2026, constructing, improving, maintaining and/or repairing public roads and bridges, including ditching and drainage and purchasing of equipment; (3) **Road District No. 19, Ward 8** - 15.51 mills tax, 10 years, 2017-2026, constructing, improving, maintaining and/or repairing public roads and bridges, including ditching and drainage and purchasing of equipment.

22. **L15-010 - St. Mary Parish School Board - (1) Consolidated School District No. 2** - 12.17 mills tax, 10 years, 2016-2025, maintaining, operating and giving additional support to public schools; (2) **Consolidated School District No. 3** - 12 mills tax, 10 years, 2016-2025, maintaining and improving public schools and other facilities; (3) **Special School District No. 3, Ward 6** - 11.75 mills tax, 10 years, 2016-2025, maintaining, operating and giving additional support to public schools.
23. **L15-017 - St. Mary Parish, Sewerage District No. 8** - 6.44 mills tax, 10 years, 2016-2025, constructing, improving, maintaining and operating sewerage works.
24. **L15-021 - St. Mary Parish, Waterworks District No. 5** - 4.6 mills tax, 10 years, 2016-2025, maintaining and operating waterworks facilities.
25. **L15-015 - St. Tammany Parish, Fire Protection District No. 1** - \$39.00 parcel fee, 10 years, 2016-2025, (1) acquiring, constructing, maintaining and operating fire protection facilities and equipment, including obtaining water; (2) paying personnel costs and (3) all purposes incidental.
26. **L15-028 - Union Parish, Hospital Service District No. 1, Wards 3, 4 and 10** - 5.11 mills tax, 10 years, 2016-2025, operations and maintenance of the Reeves Memorial Medical Center (formerly known as Tri-Ward General Hospital).
