- 2. Approval of the minutes of the January 6, 2015 Ad Hoc Election Subcommittee meeting.

## **LOCAL GOVERNMENTAL UNITS - ELECTIONS (May 2, 2015)**

- 3. L15-045 Calcasieu Parish, Gravity Drainage District No. 6, Wards 5 & 6 9.27 mills tax, 10 years, 2016-2025, (1) maintaining and constructing drains, drainage canals, dikes, levees, pumping stations and bridges and (2) purchase and upkeep of equipment for use in maintaining and constructing drains, drainage canals, dikes, levees, pumping stations and bridges.
- 4. **L15-097 DeSoto Parish Police Jury -** 5.11 mills tax, 10 years, 2016-2025, collecting and disposing of solid waste, including operating and maintaining the Parish's solid waste landfill facilities and equipment, which facilities and equipment may receive and dispose of solid waste from within and without the Parish.
- 5. **L15-122 Grant Parish, Fire Protection District No. 2 -** 13.50 mills tax, 10 years, 2015-2024, acquiring, constructing, improving, operating, maintaining and supporting facilities and equipment, including vehicles, to provide fire protection.
- 6. **L15-119 Iberville Parish School Board (1)** 1.78 mills tax, 10 years, 2016-2025, operating and maintaining alternative school programs; **(2)** 4.84 mills tax, 10 years, 2018-2027, operation and maintenance of public elementary and secondary schools; **(3)** 10.50 mills tax, 10 years, 2019-2028, salaries and benefits of employees of public elementary and secondary schools.
- 7. **L15-107 Jackson Parish Police Jury** (1) 0.6% sales tax, 10 years, beginning July 1, 2016, (a) waste management and (b) pay debt service on waste management; (2) 0.4% sales tax, 10 years, beginning July 1, 2016, (a) blacktopping roads/streets, sealing roads/streets and (b) funding into bonds or certificates of indebtedness.
- 8. **L15-117 Jefferson Parish, City of Westwego** (1) 6.0 mills tax, 10 years, 2015-2024, (a) minimum of 50% to be used for acquiring fire department vehicles and equipment, and (b) the remaining to be used for maintaining and operating fire protection services, including the acquisition of necessary equipment and facilities; (2) 2.0 mills tax, 10 years, 2015-2024, maintaining and/or operating the wastewater collection, treatment and disposal system, including salaries and benefits of sewerage department personnel; (3) 2.0 mills tax, 10 years, 2015-2024, maintaining and/or operating the drinking water treatment, storage, and distribution system, including salaries and benefits of sewerage department personnel.
- 9. L15-126 Lafourche Parish, North Lafourche Conservation, Levee and Drainage District ½% sales tax, to be levied in perpetuity, beginning July 1, 2015, (1) constructing and improving necessary levee, drainage and flood protection projects, including the acquisition of equipment and other costs incidental thereto, (2) maintenance and operation of the foregoing and (3) funding into bonds.
- 10. **L15-116 Lafourche Parish School Board, Consolidated School District No. 1 -** 4.0 mills tax, 10 years, 2015-2024, providing additional support to public elementary and secondary schools, in particular to expand the comprehensive safety and security program for students and staff, including, but not limited to, creating single-point entry at schools, additional security cameras, alarm systems, capital improvements and School Resource Officers and staff to address bullying/cyberbullying and student/related services.

- 11. **L15-105 Lincoln Parish School Board, Simsboro School District No. 3 -** 2.99 mills tax, 10 years, 2016-2025, maintaining and operating school facilities, including payment of utilities.
- 12. **L15-112 Livingston Parish Council -** 2.5 mills tax, 10 years, 2015-2024, acquiring sites for, and constructing, improving, maintaining and operating the health unit.
- 13. **L15-104 Livingston Parish, Fire Protection District No. 10 -** 11.1 mills tax, 10 years, 2015-2024, (1) purchasing fire trucks and other fire fighting equipment, (2) acquiring and constructing buildings to be used to house fire fighting equipment and (3) acquiring, maintaining, operating and developing fire protection facilities and equipment (including first response emergency vehicle services).
- 14. **L15-109 Livingston Parish School Board -** 7.0 mills tax, 10 years, 2016-2025, maintenance of public schools, including providing equipment.
- 15. **L15-099 Madison Parish Police Jury -** 2.0 mills tax, 10 years, 2015-2024, acquiring, constructing, maintaining, improving, operating and supporting fire protection facilities, equipment and services, including purchasing fire trucks and other fire fighting equipment.
- 16. L15-113 St. Bernard Parish, Southeast Louisiana Flood Protection Authority East, Lake Borgne Basin Levee District 7.5 mills tax, 30 years, 2015-2044, (1) constructing and maintaining necessary levees, levee drainage, flood protection, hurricane flood protection and all other purposes incidental and (2) funding into bonds or other evidences of indebtedness.
- 17. **L15-123 St. Charles Parish Council (1)** 4.0 mills tax, 30 years, 2015-2044, constructing, acquiring, maintaining, operating, extending and/or improving levees, facilities and structures associated with outer flood protection systems and **(2)** 2.2 mills tax, 30 years, 2015-2044, acquiring, constructing, improving, maintaining and operating wastewater facilities and systems.
- 18. **L15-124 St. Charles Parish Council -** 0.70 mills tax, 10 years, 2015-2024, **(1)** operating, maintaining and constructing facilities and **(2)** providing services with the ARC of St. Charles for all people with intellectual and developmental disabilities.
- 19. **L15-125 St. John the Baptist Parish Council -** 1.0 mills tax, 10 years, 2016-2025, constructing, operating, and maintaining the courthouse, jail and office buildings.
- 20. **L15-110 St. Landry Parish, Fire Protection District No. 3 -** 10.36 mills tax, 10 years, 2016-2025, (1) constructing, maintaining and operating fire protection facilities and (2) obtaining water for fire protection purposes.
- 21. **L15-111 St. Tammany Parish, Fire Protection District No. 12 -** 5.0 mills, 20 years, 2016-2035, acquiring, constructing, improving, maintaining and operating facilities, vehicles and equipment for the fire protection and rescue and emergency medical services, including the cost of obtaining water.
- 22. **L15-108 St. Tammany Parish, Northshore Harbor Center District -** 3.0 mills tax, 10 years, 2017-2026, development, maintenance, operation and administration of the facilities.
- 23. **L15-114 Tensas Parish, Lake Bruin Recreation and Water Conservation District** \$25 parcel fee, 3 years, 2015-2017, (1) operation, including management and control of water levels and aquatic plant growth and (2) protection and preservation of the works, improvements and properties owned or controlled.
- 24. **L15-106 Vermilion Parish School Board, Parishwide School District -** 10.0 mills tax, 10 years, 2016-2025, giving additional support to the public elementary and secondary schools, as follows; **(1)** 3.0 mills for acquiring and maintaining equipment and supplies for educational and instructional services, including library books and text books; **(2)** 5.0 mills for maintaining and improving existing public school houses and buildings, including roof repair and replacement, repair and replacement of heating and air conditioning systems; and **(3)** 2.0 mills for acquiring and maintaining school buses.

- 25. **L15-115 Vernon Parish, City of Leesville (1)** ½% sales tax, to be levied in perpetuity, beginning April 1, 2016, improving, operating and maintaining public safety services, including (a) acquire necessary police and fire protection equipment and other facilities so as to increase the level of services and protection and (b) salary increases for police and fire department personnel, including benefits, to maintain a consistent level of experience and training; (2) 8.5 mills tax, 10 years, 2015-2024, (a) improving, maintaining, operating and supporting the sewerage system, including acquiring and purchasing equipment and fixtures and (b) constructing, improving, maintaining and resurfacing public streets, including acquiring, maintaining and operating equipment.
- 26. **L15-120 Washington Parish, Bogalusa School Board, Bogalusa School District -** 6.43 mills tax, 10 years, 2016-2025, giving additional support for current operations of public elementary and secondary schools.
- 27. **L15-121 Winn Parish Police Jury -** ½% sales tax, 10 years, beginning July 1, 2015, improving, maintaining and repairing public roads and bridges.
