## TAB 4 - LOCAL POLITICAL SUBDIVISIONS - LOANS

- 3. **L14-091 LaSalle Parish, Hospital Service District No. 1** Not exceeding \$1,200,000 Certificates of Indebtedness, Series 2014, not exceeding 5%, mature no later than March 1, 2015, current expenses.
- 4. **L14-106 St. Tammany Parish, Fire Protection District No. 12 -** Not exceeding \$3,200,000 Limited Tax Certificates of Indebtedness, in one or more series, not exceeding 6%, mature no later than March 1, 2023, (1) acquisition, construction and improvements to facilities, vehicles and equipment for fire protection and rescue and emergency medical services and (2) funding a reserve, if necessary.
- 5. **L14-082 Terrebonne Parish, Houma Area Convention and Visitors Bureau -** Not exceeding \$1,500,000 Certificate of Indebtedness, Series 2014, not exceeding 6%, not exceeding 10 years, acquiring and constructing buildings and improvements including necessary equipment and furnishings.
- 6. **L14-109 Terrebonne Parish, Terrebonne Port Commission** Not exceeding \$750,000 Line of Credit, not exceeding 7%, fixed or variable, not exceeding 3 years, providing funds as needed in anticipation of receiving various state and federal grants to complete Port projects.

- 7. **L11-411A Allen Parish, West Allen Parish Water District** (1) Not exceeding \$3,440,000 Water Revenue Bonds, Series 2015, not exceeding 3.375%, not exceeding 40 years, (a) approximately \$3,323,000 Revenue Bonds, constructing and acquiring improvements, extensions and replacements to the waterworks system, including appurtenant equipment and accessories; (b) approximately \$117,000 Refunding Bonds, refunding Water Revenue Bonds, Series 2003; (2) Not exceeding \$3,294,000 Bond Anticipation Notes, not exceeding 2.18%, not exceeding 1 year, interim financing.
- 8. **L14-101 Bossier Parish, City of Bossier City (DEQ Project) -** Not exceeding \$10,000,000 Taxable Utilities Revenue Bonds, Series 2014, not exceeding 0.95%, mature no later than October 1, 2036, construct, acquire, extend or improve any work of public improvement, including but not limited to sewer portion of its combined waterworks plant and system and sewer utility system, including treatment facilities, with all necessary equipment and installations.
- 9. **L14-085 Bossier Parish Police Jury, Consolidated Waterworks/Sewerage District No. 1** (**DEQ Project**) Not exceeding \$10,000,000 Taxable Utilities Revenue Bonds, in one or more series, not exceeding 0.95%, not exceeding 22 years, construct and acquire improvements and extensions to the sewerage portion of the combine utilities system, including the payment of all necessary equipment and furnishings, and all engineering, legal and other incidental costs and fees.
- 10. **L14-102 Calcasieu Parish School Board, Sales Tax District No. 3 -** Not exceeding \$6,400,000 Sales Tax Revenue Refunding Bonds, ST Series 2014, taxable or tax-exempt, not exceeding 3%, mature no later than November 1, 2020, defease and refund 2014-2020 maturities of Sales Tax Revenue Refunding Bonds, ST Series 2004.

- 11. **L14-093 Iberia Parish School Board, Parishwide School District -** Not exceeding \$22,000,000 General Obligation School Refunding Bonds, not exceeding 5%, mature no later than March 1, 2026, refunding all or a portion of General Obligation School Bonds, Series 2006.
- 12. L14-097 Jefferson Davis Parish, Hospital Service District No. 1 (Jennings American Legion Hospital Project) Not exceeding \$10,000,000 Hospital Revenue Bonds, Series 2014, in one or more series, not exceeding 5.5%, not exceeding 20 years, (1) renovating and improving Jennings American Legion Hospital's buildings and facilities, (2) acquiring necessary furnishings and equipment and (3) purchasing radiology equipment, including but not limited to, a magnetic resonance imaging machine, a computed tomography scanning machine and other related equipment.
- 13. **L14-066 Ouachita Parish, Town of Sterlington (DEQ Project) -** Not exceeding \$1,500,000 Taxable Utilities Revenue Bonds, in one or more series, not exceeding 0.95%, not exceeding 22 years, acquiring and constructing additions, extensions and improvements to the wastewater portion of the combined drinking water and wastewater collection, treatment and disposal system, including equipment and fixtures.
- 14. **L14-075 Rapides Parish Police Jury, Fire Protection District No. 15 -** Not exceeding \$700,000 Limited Tax Certificates of Indebtedness, Series 2014, not exceeding 6%, not exceeding 10 years, acquiring, constructing and improving fire protection facilities and equipment.
- 15. **L14-081 Sabine Parish, Village of Florien (DEQ Project)** Not exceeding \$199,430 Taxable Sewer Revenue Bonds, Series 2014, non-interest bearing, not exceeding 20 years, acquiring, constructing and installing improvements, extensions and additions to the wastewater collection, treatment and disposal system.
- 16. **L14-110 St. James Parish, Hospital Service District No. 1 -** Not exceeding \$8,000,000 Hospital Revenue Refunding Bonds, not exceeding 6%, mature no later than June 1, 2029, refunding all or a portion of Taxable Hospital Revenue Bonds, Series 2008A, B, C and D.
- 17. **L14-111 St. John the Baptist Parish Council -** Not exceeding \$3,000,000 Sales Tax Bonds, not exceeding 6%, not exceeding 20 years, acquiring fire fighting equipment, lands, buildings and machinery, as may be necessary in the areas of the LaPlace Volunteer Fire Department.
- 18. **L14-074 Terrebonne Parish Council (DEQ Project)** Not exceeding \$2,000,000 Taxable Sewer Revenue Bonds, Series 2014, non-interest bearing, not exceeding 20 years, relocating the discharge point for the South Terrebonne Wastewater Treatment Plant from the Houma Navigation Canal to an adjacent wetland.
- 19. **L14-103 Vermilion Parish, City of Abbeville -** Not exceeding \$3,000,000 Sales Tax Revenue Bonds, not exceeding 6%, not exceeding 20 years, constructing, acquiring or improving various works of permanent public improvement.

20. **S14-005 - Louisiana Community Development Authority (East Baton Rouge Sewerage Commission Project) -** Not exceeding \$230,000,000 Subordinate Lien Revenue Bonds, Series 2014A, not exceeding 6%, not exceeding 35 years, (1) constructing and acquiring sewers and sewerage disposal works, including the necessary sites, right-of-way, machinery and equipment; (2) funding a debt service reserve fund, if required; (3) funding a capitalized interest fund, if necessary.

21. **S14-008 - Louisiana Community Development Authority (AHA - Marrero, LLC Project) -** Not exceeding \$6,000,000 Multifamily Housing Revenue Bonds, in one or more series, taxable and/or tax-exempt, not exceeding 12%, not exceeding 37 years, acquisition, rehabilitation, and equipping of a 78-unit multifamily housing complex located in Marrero, Jefferson Parish.

22. **S14-003 - East Baton Rouge Mortgage Finance Authority -** Not exceeding \$50,000,000 Mortgage Revenue Bonds (Volume Cap), in one or more series, not exceeding 12%, not exceeding 42 years, (1) funding a mortgage lending program by implementing the Single Family Mortgage Revenue Bond Program and Mortgage Credit Certificate Program to finance the purchases of securities primarily to low and moderate first-time homebuyers, (2) making deposits into certain funds as may be required to secure and successfully market the Bonds, (3) paying capitalized interest and (4) approving the Notice of Sale.
