- 3. **L12-163 Allen Parish, Hospital Service District No. 3 -** Not exceeding \$500,000 Certificates of Indebtedness, not exceeding 4%, mature no later than 12 months from date of issuance, current expenses.
- 4. **L12-171 Franklin Parish, Hospital Service District No. 1 -** Not exceeding \$1,000,000 Certificates of Indebtedness, Series 2012, not exceeding 6%, mature no later than 12 months from date of issuance, current expenses.
- 5. **L12-186 Madison Parish, Hospital Service District -** Not exceeding \$2,000,000 Revenue Anticipation Notes, Series 2012, not exceeding fixed or variable rate of 6%, maturing on or before March 1, 2013, current expenses.
- 6. L12-187 Regional Planning and Development Commission, District No. 4 (dba Acadiana Regional Development District) Not exceeding \$500,000 Refunding Certificates, Series 2012, in one or more series, not exceeding 6%, not exceeding 10 years, refunding Taxable Grant Anticipation Notes, Series 2009; District No. 4 is comprised of Acadia, Evangeline, Iberia, Lafayette, St. Landry, St, Martin, St. Mary & Vermilion Parishes.
- 7. **L12-194 Regional Planning and Development Commission, District No. 4 (dba Acadiana Regional Development District) -** Approval of a previously executed Promissory Note in the amount of not exceeding \$100,000, not exceeding 10%, maturing no later than April 1, 2018, expansion and development of services under Acadiana Regional Development District's subsidiary, Enterprise Consortium of the Gulf Coast; District No. 4 is comprised of Acadia, Evangeline, Iberia, Lafayette, St. Landry, St, Martin, St. Mary & Vermilion Parishes.
- 8. **L12-149 Sabine Parish, Ebarb Waterworks District -** Not exceeding \$100,000 Certificates of Indebtedness, Series 2012, not exceeding 5.5%, not exceeding 5 years, (1) installing a water well and (2) acquiring waterworks equipment and fixtures.
- 9. **L12-165 Sabine Parish, Ebarb Waterworks District** Approval of a previously executed Promissory Note in the amount of not exceeding \$115,000, not exceeding 5.9%, not exceeding 10 years, drilling test wells.

- 15. **L12-178 Calcasieu Parish School Board, School District No. 25** Not exceeding \$4,000,000 General Obligation Refunding Bonds, Series 2012, not exceeding 4%, mature no later than February 15, 2020, refunding General Obligation Refunding Bonds, Series 2005, maturing February 15, 2014 through 2020.
- 16. **L12-179 Calcasieu Parish School Board, School District No. 30 -** Not exceeding \$9,000,000 General Obligation Refunding Bonds, Series 2012A, not exceeding 5%, mature no later than February 15, 2029, refunding General Obligation Public School Improvement Bonds, Series 2009, maturing February 15, 2015 through 2029.
- 17. **L12-180 Calcasieu Parish School Board, School District No. 31 -** Not exceeding \$8,000,000 General Obligation Refunding Bonds, Series 2012, not exceeding 4%, mature no later than March 1, 2022, refunding General Obligation Refunding Bonds, Series 2005B, maturing March 1, 2014 through 2022.
- 18. **L11-143A Iberia Parish, City of Jeanerette (1)** Not exceeding \$2,463,000 Water Revenue Bonds, not exceeding 2.375%, not exceeding 40 years, constructing and acquiring improvements, renovations and replacements to the waterworks system, including equipment, and accessories; and **(2)** Not exceeding \$2,463,000 Bond Anticipation Notes, not exceeding 4%, mature no later than 18 months, interim financing.
- 19. **L12-185 Iberia Parish Council -** Not exceeding \$5,000,000 Revenue Bonds, Series 2012, not exceeding 5%, not exceeding 20 years, constructing and acquiring capital improvements at the Acadiana Fairgrounds.
- 20. **L12-156 Livingston Parish Council -** Not to exceed \$6,330,000 General Obligation Refunding Bonds, Series 2012, not to exceed 3%, mature no later than March 1, 2024, refunding General Obligation Bonds, Series 2004, maturing 2015 through 2024.
- 21. **L12-191 Livingston Parish School Board, School District No. 22** Not exceeding \$7,180,000 General Obligation School Refunding Bonds, not exceeding 5%, mature no later than March 1, 2022; refunding all or any portion of the General Obligation School Bonds, Series 1996C, Series 2002 and Series 2003.
- 22. **L12-189 Livingston Parish, Water District, Ward 2 -** Not exceeding \$17,500,000 Water Revenue Refunding Bonds, Series 2012, in one or more series, taxable or tax-exempt, not exceeding 4%, mature no later than April 1, 2029, refund Water Revenue Bonds, Series 2000 and Waterworks System Revenue Bonds, Series 2004 and 2005.

- 23. **L12-183 Madison Parish, City of Tallulah -** Not exceeding \$5,275,000 Water Refunding Bonds, Series 2012, not exceeding 4.55%, not exceeding 20 years, (1) refunding the Water Meter Lease and Water Revenue Bonds, Series 2001 (91-03), Series 2001 (91-06) and Series 2004 (91-09), and (2) funding a debt service reserve.
- 24. **L10-388 Morehouse Parish Law Enforcement District -** Not exceeding \$525,000 Revenue Bonds, in one or more series, not to exceed 6%, not to exceed 10 years, (1) not more than \$202,000, plus a pro-rata portion of the costs of issuance, for Refunding and extending the District's Revenue Refunding Bonds, Series 1997; (2) the balance of Bonds for paying all or any part of the cost of constructing and acquiring additions, improvements, extensions, or enlargements at the Collinston Detention Center.
- 25. **L12-172 Morehouse Parish School Board, Parishwide School District No. A** Not exceeding \$4,400,000 General Obligation School Refunding Bonds, not to exceed 4%, no later than March 1, 2029, refunding General Obligation School Bonds, Series 2004.
- 26. **L12-190 Orleans Parish, Public Belt Railroad Commission of the City of New Orleans -** Not exceeding \$1,500,000 Taxable Indebtedness, Series 2012, not to exceed 5.3% (not to exceed 10% in the event of default, subject to a clawback provision), mature no later than June 1, 2017, acquiring, constructing and equipping of a rail extension project consisting of a spur rail track connecting with the main line on and over a right-of-use and servitude of rail passage granted over land leased by Transportation Consultants, Inc. for expansion capacity.
- 27. **L12-188 Ouachita Parish, City of Monroe -** Not exceeding \$17,000,000 Sales Tax Refunding Bonds, Series 2012, in one or more series, not exceeding 5%, mature no later than July 1, 2027, (1) refunding a portion of Sales Tax Bonds, Series 2003 and (2) paying the premium for a bond insurance policy and a reserve fund surety.
- 28. **L12-174 Richland Parish, Town of Delhi** Not exceeding \$1,870,000 Water Revenue Bonds, not exceeding 3.45%, not exceeding 10 years, constructing and acquiring improvements and replacements to the waterworks system, including equipment and fixtures.
- 29. **L12-175 St. Bernard Parish Council -** Not exceeding \$15,000,000 Sales Tax Bonds, Series 2012, not exceeding 6%, not exceeding 20 years, capital improvements.
- 30. **L12-184 St. John the Baptist Parish School Board, School District No. 1 -** Not exceeding \$4,500,000 General Obligation School Refunding Bonds, not exceeding 4%, mature no later than March 1, 2022, refunding General Obligation School Refunding Bonds, Series 2001 and General Obligation School Bonds, Series 2002.
- 31. **L12-182 St. Landry Parish, City of Opelousas (1)** Not exceeding \$4,700,000 Public Improvement Refunding Bonds, not exceeding 5%, mature not later than September 1, 2025, refunding all or portion of Public Improvement Bonds, Series 2005 and **(2)** not exceeding \$6,300,000 Utility Revenue Refunding Bonds, not exceeding 5%, mature not later than September 1, 2025, refunding all or portion of Utility Revenue Bonds, Series 1999 and 2000.
- 32. **L12-168 St. Tammany Parish, Hospital Service District No. 2 -** Not exceeding \$9,500,000 General Obligation Refunding Bonds, not to exceed 3.5%, mature no later than March 1, 2024, refunding all or a portion of General Obligation Bonds, Series 2004B.
