- 3. **L15-231 Allen Parish, Elizabeth Recreation District No. 3** 11.28 mills tax, 10 years, 2016-2025, acquiring, constructing, improving, maintaining, and/or operating recreational facilities.
- 4. L15-249 East Feliciana Parish School Board Parishwide (1) 1% sales tax, 10 years, beginning July 1, 2017, (1) 91% of proceeds for salaries and benefits for all employees of the school system and (2) 9% of proceeds for maintaining and operating public schools; School District No. 1 (2) 17.0 mills tax, 10 years, 2017-2026, salaries and benefits for teachers and other employees; (3) 1% sales tax, 10 years, beginning July 1, 2017, (a) minimum of one-half of proceeds for paying teachers' salaries and benefits and (b) remaining proceeds for constructing, supporting, maintaining and operating public schools.
- 5. **L15-248 Evangeline Parish, Fire Protection District No. 2** 5.63 mills tax, 10 years 2017-2026, (1) acquiring, constructing, improving, maintaining, and operating fire protection facilities, including purchasing fire trucks and equipment and (2) paying salaries of firemen.
- 6. **L15-245 Iberia Parish Council (1)** Amend Sections 2-01(A) and 2-05(A) of the Home Rule Charter relative to composition and compensation of the Parish Council members; **(2)** Amend Section 2-04(B) of the Home Rule Charter relative to vacancies on the Parish Council; **(3)** Amend Section 3-07(B) of the Home Rule Charter relative to vacancies in the office of the Parish President; **(4)** Add Section 2-01(E) and amend Section 3-02 of the Home Rule Charter relative to terms of the Parish Council and Parish President; **(5)** Amend Section 7-06(F) of the Home Rule Charter relative to terms of members of Boards and Commissions.
- 7. **L15-244 Lafourche Parish, Fire Protection District No. 8-C -** \$45 parcel fee, 10 years, 2015-2024, **(1)** acquiring, constructing, maintaining and operating fire protection facilities and equipment, including obtaining water for fire protection purposes and **(2)** all purposes incidental.
