<u>Local Government Units - Elections (December 10, 2022)</u>

3. L22-241 - Bienville Parish, Town of Gibsland

1% sales tax, 10 years, beginning January 1, 2023, supporting general operations.

4. L22-255 - Calcasieu Parish, Town of Vinton

½% sales tax, 10 years, beginning January 1, 2023, **(1)** 75% for maintenance and overlay of hard surfaced streets and **(2)** 25% for **(a)** maintenance of Fire Department buildings, equipment, vehicles, **(b)** payment of Fire Department insurance and utility bills and **(c)** acquiring new equipment or vehicles for fire protection.

5. L22-240 - Livingston Parish Council

5.0 mills tax, 10 years, 2023-2032, **(1)** constructing, operating and maintaining roads and bridges and **(2)** funding into bonds for said capital improvements.

6. L22-257 - St. Martin Parish, Town of Henderson

4.0% hotel occupancy tax, to be levied in perpetuity, beginning January 1, 2023, economic development, promotion of tourism, and related infrastructure.

7. L22-242 - Vernon Parish Police Jury, Road District No. 3

(1) 11.89 mills tax, 1 year, 2022, maintaining roads and bridges; (2) 4.77 mills tax, 1 year, 2022, constructing and improving roads and bridges.

8. L22-222 - West Feliciana Parish Council

Amend the Home Rule Charter relative to (1) increasing term limits of Parish President from two terms to three terms and (2) confirming the election cycle to coincide with regular Louisiana gubernatorial elections.
