## TAB 3 - LOCAL GOVERNMENTAL UNITS - ELECTIONS (March 28, 2015)

3. **L14-393 - Calcasieu Parish Law Enforcement District -** ½% sales tax, 10 years, beginning October 1, 2016, (1) maintenance of the salary schedule for deputies; (2) providing for future cost of living salary adjustments; (3) continued funding of the Patrol and Corrections Divisions and related law enforcement functions; (4) maintenance of Emergency Fund Balance or Reserve to be utilized in the event of an emergency; (5) provide continuity in operations.

- 4. **L14-392 Beauregard Parish Police Jury -** Not exceeding \$2,000,000 Limited Tax Bonds, not exceeding 4.5%, mature no later than March 1, 2027, constructing, expanding, improving and renovating the Beauregard Parish Courthouse, including acquiring, fixtures and furnishings.
- 5. **L14-400 Caddo Parish School Board, Parishwide School District -** Not exceeding \$17,000,000 General Obligation School Refunding Bonds, not exceeding 5%, mature no later than March 1, 2032, refunding all or a portion of General Obligation School Bonds, Series 2007.
- 6. **L14-399 Claiborne Parish, Town of Homer, Claiborne Memorial Medical Center -** Not exceeding \$500,000 Hospital Revenue Bonds, Series 2014, in one or more series, not exceeding 5%, not exceeding 10 years, renovations and improvements, including ten new patient rooms for a geriatric psychiatric unit on the campus of Claiborne Memorial Medical Center.
- 7. L14-395 East Baton Rouge Parish, East Baton Rouge Sewerage Commission (1) Not exceeding \$140,000,000 Revenue Refunding Bonds, Series 2014A (Taxable), not exceeding 6%, mature no later than February 1, 2031, refunding or defeasing all or a portion of Revenue Refunding Bonds, Series 2006A; (2) not exceeding \$240,000,000 Revenue Refunding Bonds, Series 2014B (Tax-Exempt), not exceeding 6%, mature no later than February 1, 2039, refunding or defeasing all or portion of Revenue Bonds, Series 2006B and 2009A.
- 8. **L14-390 Franklin Parish, Hospital Service District No. 1 -** Not exceeding \$4,000,000 Limited Tax Revenue Bonds, Series 2014, not exceeding 4%, not exceeding 20 years, acquire, construct and improve public improvements, including acquisition of equipment.
- 9. L14-397 Livingston Parish, Juban Crossing Economic Development District Not exceeding \$41,000,000 TIF Revenue Refunding Bonds, in one or more series, not exceeding 9%, not exceeding 29 years, (1) Series A, refunding Revenue Bonds (Road Projects), Series 2013A; (2) Series B, refunding Revenue Bonds (Drainage Projects), Series 2013B; (3) Series C, refunding Revenue Bonds (General Infrastructure Projects), Series 2013C; and (4) Series A, B and C include funding debt service reserve funds

- 10. **L14-157 Morehouse Parish, City of Bastrop (DEQ Project)** Not exceeding \$1,700,000 Taxable Sewer Revenue Bonds, in one or more series, not exceeding 0.95%, not exceeding 22 years, (1) installing a M2 Renewables MicroScreen system and (2) rehabilitating two existing lift stations by the construction of improvements, extensions and replacements.
- 11. **L14-396 Rapides Parish, Recreation District, Ward 10** Not exceeding \$550,000 Limited Tax Certificates of Indebtedness, not exceeding 6%, not exceeding 11 years, improving and maintaining recreational facilities.
- 12. **L14-391 Tangipahoa Parish, Town of Independence -** Not exceeding \$150,000 Limited Tax Bonds, Series 2015, not exceeding 2.75%, mature no later than March 1, 2027, paying a portion of constructing a police station, including acquiring and installing equipment, furniture and fixtures.
- 13. **L14-398 Tangipahoa Parish, Water District** Not exceeding \$5,000,000 Water Revenue Bonds, in one or more series, not exceeding 5%, not exceeding 30 years, (1) construct and acquire improvements and extensions to the waterworks system and (2) fund a reserve fund or purchase a reserve fund surety, if necessary.

15. **S14-036 - Louisiana Correctional Facilities Corporation (Prison Enterprises Project)** - Not exceeding \$3,800,000 Lease Revenue Bonds (NSTSD), in one or more series, not exceeding 5%, not exceeding 26 years, (1) design, acquisition, rehabilitation, construction and equipping of an approximately 34,000 square foot facility in Baton Rouge to house the headquarters of the Prison Enterprises division of the Department of Public Safety and Corrections; (2) fund a debt service reserve fund, if necessary, (3) pay capitalized interest, in necessary, and (4) pay costs of issuance, including the premium for a bond insurance policy, if required.
