Charles Brossette and attorney Trippe Hawthorne were present on behalf of CHARLES BRADFORD BROSSETTE. Mr. Brossette was sworn in. Ms. Morgan presented a summary of the allegations. Mr. Brossette entered a plea of no contest under an agreement in which Mr. Brossette voluntarily consents to a one-year suspension of his qualified party status for Asbestos, running concurrently with his Louisiana Department of Environmental Quality (“DEQ”) suspension. On a motion made, seconded, and unanimously passed, the plea was accepted. Investigator Jarrod Watson, who was previously sworn in, was called to the stand. Mr. Watson reviewed the exhibit packet and provided testimony to the board. Exhibits 1, 2A through F, 3 and 4 were introduced into evidence by Mr. Larry Demmons and admitted without objection. On motion made, seconded, and unanimously passed, the board accepted the plea of no contest and the voluntary suspension of the qualified party status for Asbestos to run concurrently through the DEQ suspension term concluding in August of 2026 and assessed \$1,000 for administrative costs.
