C. QUALIFYING PARTY HEARING(S):

1. **AP GULF STATES, INC.**, Richardson, Texas – La. R.S. 37:2156.1, Sec. 103 Rules and Regulations of the Board.

Ms. Dupuy gave a summary of the allegations. No one was present on behalf of AP GULF STATES, INC. Ms. Sims entered into evidence the exhibit packet and it was admitted. Mr. Fenet made a motion to suspend the commercial license for AP GULF STATES, INC. Mr. Graham seconded. The motion passed.

Mr. Clouatre made a motion to remove the Highway, Street, and Bridge classification from the commercial license for RES CONTRACTORS LLC. Mr. Graham seconded. The motion passed.

Mr. Talbot recused himself from this matter. Ms. Dupuy gave a summary of the allegations. Ms. Dupuy stated that the incorrect commercial license number was listed on the agenda, and stated the correct license number should be license number 49734. Mr. Clouatre made a motion to amend the agenda for the correct commercial license number. Mr. Graham seconded. The motion passed. Ms. Sims entered into evidence the exhibit packet and it was admitted. Ahmad Trench was present on behalf of BBT CONSTRUCTION MANAGEMENT, LLC and was sworn in. Mr. Trench gave a statement. Mr. Trench presented documents to the board and they were admitted. Mr. Clouatre made a motion to suspend the commercial license for BBT CONSTRUCTION MANAGEMENT, LLC and to uphold the suspension of the Residential license pending satisfaction of other matters. Mr. Weston seconded. The motion passed.

Attorney Rudolph Estess, Jr. was present on behalf of STEVEN GARY ESTESS and PELICAN STATE LAND COMPANY L.L.C. Ms. Sims requested matters E1 and E2 to be moved to the end of the agenda. Mr. Clouatre made a motion to move agenda items E1 and E2 to the end of the agenda to be heard after all other Compliance Hearings. Mr. Weston seconded. The motion passed.

Ms. Hughes gave a summary of the allegations for matters E1 and E2. Elaine Riggins, Emma Payne, Steven Hunter Estess, and Gary McNamara were sworn in as potential witnesses for this matter. Mr. Rudolph Estess presented a written request to the Board which included a request to sequester the witnesses during the proceedings. Ms. Sims gave a response to the motion. Judge White denied Mr. Rudolph Estess's request to sequester the witnesses. Mr. Rudolph Estess entered a denial plea for both entities. Mr. Meredith made a motion to accept the plea. Mr. Dupuy seconded.

The motion passed. Investigator Carl Bourque, who was previously sworn in, was called to the stand and reviewed the exhibit packet. Ms. Sims entered the exhibit packet into evidence and it was admitted. Mr. Rudolph Estess cross-examined Mr. Bourque regarding the exhibit packet and the allegations. Elaine Riggins was called to the stand by Ms. Sims. Ms. Riggins was questioned by Ms. Sims and was cross-examined by Mr. Rudolph Estess. Ms. Sims called Steven Hunter Estess to the stand and was questioned regarding these matters. Mr. Rudolph Estess called Gary McNamara to the stand and was questioned regarding these matters. Emma Payne was called to the stand by Mr. Rudolph Estess and questioned regarding these matters. Mr. Rudolph Estess presented documents as evidence to the board and they were admitted. Mr. Rudolph Estess called Steven Hunter Estess back to the stand and Steven Hunter Estess gave a statement. Mr. Meredith made a motion to find PELICAN STATE LAND COMPANY L.L.C. to be in violation of La. R.S. 2158 (A)(2). Mr. Weston seconded. The motion passed. Mr. Rudolph Estess changed the initial denial plea to a no contest plea for the remaining charges of La. R.S. 2158 (A)(3), (A)(9) and Rules and Regulations of the Board Sec. 1503(D) for STEVEN GARY ESTESS and PELICAN STATE LAND COMPANY L.L.C. Mr. Jones made a motion to accept the no contest plea for both entities. Mr. Weston seconded. The motion passed. Mr. Graham made a motion to assess a fine of \$2000 plus \$500 in administrative costs for each entity and one year probation for each entity. Mr. Weston seconded. The motion passed with one opposed.

Ms. Hughes gave a summary of the allegations. JULES LEDET was present and was sworn in. Mr. Ledet entered a no contest plea. Mr. Meredith made a motion to accept the plea. Mr. Jones seconded. The motion passed. Mr. Ledet gave a statement and presented documents to the board. The documents were admitted. Mr. Talbot made a motion to fine JULES LEDET \$1000 plus \$500 in administrative costs. Mr. Fenet seconded. The motion passed.

4. **SUPERIOR LABOR SERVICES, INC.**, Houma, Louisiana – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations. Dan Falgout was present on behalf of SUPERIOR LABOR SERVICES, INC. and was sworn in. Mr. Falgout entered a denial plea. Investigator Robert Guesnon was called to the stand and was sworn in. Mr. Guesnon reviewed the exhibit packet. Ms. Sims entered the exhibit packet into evidence and it was admitted. Mr. Falgout questioned Mr. Guesnon and also gave a statement. Mr. Talbot made a motion to take no action and to dismiss the case. Mr. Fenet seconded. The motion passed.

5. **LARRY CHERNIK D/B/A LGC PLUMBING REPAIR**, Denham Springs, Louisiana – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations. Larry Chernick was present on behalf of LARRY CHERNIK D/B/A LGC PLUMBING REPAIR and was sworn in. Mr. Chernick entered a guilty plea. Mr. Talbot made a motion to accept the plea. Mr. Cloutre seconded. The motion passed. Mr. Chernick gave a statement. Mr. Talbot made a motion fine LARRY CHERNIK D/B/A LGC PLUMBING REPAIR \$500 plus \$500 in administrative cost allowing that if the company does not obtain a commercial license within 60 days the fine will be increased to \$1000. Mr. Graham seconded. The motion passed.

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by AVANI ENVIRONMENTAL INTL., INC. Mr. Meredith made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Cloutre seconded. The motion passed.

Ms. Hughes gave a summary of the allegations. Attorney Nancy Richeaux and Charles Blair were present on behalf of BLAIR CONSTRUCTION COMPANY, INC. Father Patrick Edwards was also present on behalf of St. Margaret's Episcopal Church. Mr. Blair and Father Edwards were sworn in. Ms. Richeaux entered a denial plea based on exemption 2157 from the Louisiana *Contractor's Licensing Law and Rules and Regulations* book. Investigator Johnny Rogers was

called to the stand. Mr. Jones made a motion to dismiss this matter. Mr. Meredith seconded. The motion passed.

8. **BRIDGES BUILDERS CONSTRUCTION GROUP, LLC**, New Orleans, Louisiana – La. R.S. 37:2167(A) and 2158(A)(9).

Ms. Hughes gave a summary of the allegations. Earin Bridges was present on behalf of BRIDGES BUILDERS CONSTRUCTION GROUP, LLC and was sworn in. Mr. Bridges entered a no contest plea. Mr. Meredith made a motion to accept the plea. Mr. Jones seconded. The motion passed. Mr. Bridges gave a statement. Ms. Sims dismissed the second violation La. R.S. 37:2158 (A)(9). Mr. Cloutre made a motion fine BRIDGES BUILDERS CONSTRUCTION GROUP, LLC \$1000 plus \$500 in administrative costs allowing that the fine to be waived if the company obtains a residential license by the next board meeting and if the license is not obtained to issue a cease and desist order. Mr. Meredith seconded. The motion passed.

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by M & D SERVICES, LLC. Mr. Meredith made a motion to deny the settlement offer. Mr. Weston seconded. The motion passed. Mr. Meredith made a motion to suspend this matter until the next commercial board meeting. Mr. Badeaux seconded. The motion passed.
