Mr. Bourgeois entered a plea of not guilty. Investigator Laurie Larose, who was previously sworn, was called to the stand. Mr. Abadie submitted a motion to recuse the board as a whole and a separate motion to recuse Mr. Mallet and Mr. Temple. After discussion, Mr. Mallet and Mr. Temple voluntarily recused themselves. Mr. Abadie submitted a motion to dismiss the case due to alleged insufficiencies in the notices of violation and hearing.

Ms. Starks requested a 10-minute break at 11:48 a.m. The meeting resumed at 12:00 p.m., at which time roll was called. Members of the board present were William J. Clouatre, Vice-Chairman; Kristen Brown; Kyle Condon; Courtney Fenet Jr; David Gallo; Adam Guinn; Steven Hackworth; Harvey Honore; Donald Lambert; Andy Lopez; Garland Meredith; and Keith Tillage. There being a quorum present, the hearing resumed.

Mr. Landreneau discussed the motion to dismiss submitted by Mr. Abadie which also requested the hearing officer make decisions as to the constitutionality of rules and laws. Ms. Starks bypassed that part of the motion as outside her authority and denied the motion to dismiss.

Mr. Abadie requested this case be referred to the court for a trial by jury. Ms. Starks denied the request.

Ms. Larose reviewed the exhibit packet and provided testimony to the board regarding the packet. Mr. Landreneau entered the exhibit packet into evidence with objection by Mr. Abadie to specific documents contained therein noted and overruled by Ms. Starks.

Ms. Larose provided additional testimony to the board under direct examination by Mr. Landreneau with objections by Mr. Abadie noted by Ms. Starks. Mr. Larose provided additional testimony under cross-examination by Mr. Abadie.

Mr. Abadie moved to suppress all the information gathered based on Mr. Bourgeois not receiving a Miranda warning and submitted a document related to his motion filed by the Attorney General's Office, further requesting that Ms. Starks recuse herself from the proceedings as an employee of the Attorney General's Office. Ms. Starks denied the motions to suppress and recuse herself.

Nita Lindsley was sworn in as a witness for the LSLBC and provided testimony under direct examination by Mr. Landreneau and under cross-examination by Mr. Abadie.

Mr. Bourgeois provided testimony to the board under direct examination by Mr. Abadie and cross-examination by Mr. Landreneau.

After closing comments by Mr. Landreneau and Mr. Abadie, Mr. Tillage made a motion to find JAMES BOURGEOIS CONTRACTOR, INC. guilty. The motion was seconded and passed unanimously. Mr. Tillage made a motion to assess an administrative penalty of a \$5,000 fine plus \$1,000 for administrative costs and for the suspension of the license to remain in effect until records are submitted, reviewed, and deemed acceptable to staff. The motion was seconded and passed unanimously.
