Curtis M. Loftin was present on behalf of CURTIS M. LOFTIN BUILDER, LLC and was sworn in. Ms. Evans gave a summary of the allegations. Mr. Loftin entered a no contest plea. Mr. Jones recused himself from this matter. On motion made, seconded, and unanimously passed, the plea was accepted. Brad Hassert, Compliance Director, who was previously sworn, was called to the stand. Mr. Hassert reviewed the exhibit packet and provided testimony to the board. Mr. Landreneau entered the exhibit packet into evidence, and it was admitted. Mr. Loftin gave a statement to the board. The board questioned Mr. Loftin. Ms. Evans gave a summary of the allegations. Mr. Miller entered a denial plea. Brad Hassert, Compliance Director, who was previously sworn, was called to the stand and reviewed the exhibit packet. Mr. Allen objected to the admission of the exhibit packet into evidence. Mr. Landreneau rebutted that the documents were admissible in an administrative hearing. Mr. Wales entered the exhibit packet into evidence, and it was admitted. Mr. Hassert reviewed the exhibit packet and provided testimony to the board. Mr. Landreneau questioned Mr. Miller. The board questioned Mr. Miller. After discussion, a motion was made, seconded, and unanimously passed to find ALLEN MILLER D/B/A AK CONSTRUCTION to be in violation. A motion was made and seconded to assess a fine of \$750 plus \$1000 costs. After discussion, an amended motion was made and seconded

to assess a \$500 fine plus \$500 costs. The motion passed by a vote of 9 yeas by board members Barron, Broussard, Dupuy, Fenet, Gallo, Jones, Rushing, Temple, and Weston and 5 nays by board members Bordelon, Brown, Joseph, Lambert, and Meredith.

Brad Hassert, Compliance Director, who was previously sworn, was called to the stand. Mr. Hassert reviewed the exhibit packet and provided testimony to the board. 
Mr. Landreneau made a statement to the board regarding the appeal of Coastal Bridge Company, L.L.C. Mr. Landreneau stated the 1st Circuit Court of Appeals affirmed the revocation of their license, and he will provide the judgment to the board members.
