All Commissioners were given a copy of the new port pamphlet.

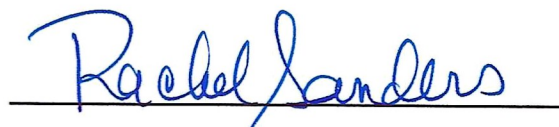
BUSINESS AFTER HOURS:
