The conference packets for all Board members attending the IRPT Conference will be given out at the Noon meeting on Monday, August 10th.

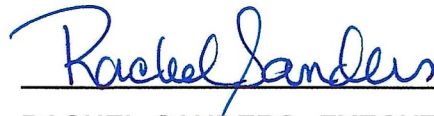
