Josh presented two bills: one for \$17,693.75 to Amethyst and one \$3,575.00 to Lazenby and Associates for engineering. Commissioner Lee moved that the GOPC authorize Terri Odom to pay the two bills. Commissioner Manning seconded. Motion passed.

## **Operations Report**

Paul Trichel with Ouachita Terminals said that year end traffic slows and they have seen that at the port. He will be attending a Louisiana Port Authority meeting and will get more information on the tax credits for ports in Louisiana. They should be close to pinning everything down as the new rules are expected to be implemented on March 1, 2014.

Paul Trichel with Ouachita Terminals said that rock had been coming in for several weeks. Commissioner Lee asked about pellet operations coming to the Port. Paul said it was not possible because the product is handled too much before it reaches the Port and causes it to break down.

with Kansas City Southern Railroad. Josh reported that he has a few questions about the cost of the deposits on the switches. Josh advised that he is discussing the issues with Terry and Steve North. Josh advised he has a proposed price that is \$50K less than the current proposal.

### **Operations Report**

Paul Trichel with Ouachita Terminals said Graphic Packaging has had power outages due to the weather and they are playing catch up at this time.

## Other

Commissioner Odom reported that the Jindal Administration is requiring the GOP to post all notices, minutes and audits on the internet. The GOP also needs to provide a list of dates that the GOP members were appointed.
