I. Call to Order - Chairwoman, Mayra Pineda

Ms. Wollfarth stated that expenses appear to be in line with the budget for the current year, and she does not see any large or unexpected expenses to report on.

- JEDCO is embarking on an Attraction Campaign to help drive interest in Jefferson Parish. Once the tagline is chosen, they will begin developing a logo, visuals, and messaging.
- NAI Site Selectors Group, representing Avondale Global Gateway, is working with JEDCO to develop a site selector package to distribute to prospects.
- Cornerstone/UBE groundbreaking ceremony scheduled for mid-November. Japanese leadership planning to attend the event.
