I. Call to Order - Chairman Tom Gennaro

II. Public Comments on Agenda Items

III. Unfinished and New Business

 Request to increase the not-to-exceed amount on professional fees from \$125,500 to \$144,890 for the consulting services contract between JEDCO and Perkins+Will (LA), An Architectural Corporation, related to Phase 2 Implementation of the Churchill Technology & Business Park Master Plan – Lacey Bordelon Motion by Jim Hudson, seconded by Mayra Pineda to approve the request to increase the not-to-exceed from \$125,500 to \$144,890. The motion passed unanimously.

 Resolution authorizing execution of contract with Leaaf Environmental for environmental services under EPA Cooperative Agreement BF-01F95601-0 – Annalisa Kelly

To conduct the environmental work required under the \$600,000 EPA Brownfield Assessment Coalition grant, JEDCO issued a Request for Qualifications (RFQ) for qualified environmental professional firms to perform environmental assessments, prepare cleanup plans, and other services. Leaaf Environmental, LLC was one of the two highest-scoring, and therefore selected along with Terracon Consultants, Inc. The total amount awarded to Leaaf Environmental, LLC, for activities to be performed under this contract is anticipated to be approximately \$172,700 but in no event in excess of \$345,000. Ms. Kelley provided more information regarding the scope of work detailed in the contract. Following discussion, Lloyd Clark motioned, seconded by Gene Sausse to approve the resolution authorizing execution of the contract. The motion passed unanimously.

 Resolution authorizing execution of contract with Terracon Consultants, Inc. for environmental services under EPA Cooperative Agreement BF-01F95601-0 – Annalisa Kelly

Gene Sausse motioned, seconded by Lesha Freeland to defer this item to the March 31, 2022 Executive Committee meeting. The motion passed unanimously.
