PORT OF IBERIA DISTRICT BOARD OF COMMISSIONERS REGULAR MONTHLY MEETING AGENDA TUESDAY, APRIL 20, 2021 PORT ADMINISTRATIVE OFFICE – 5:30 P.M. MINUTES

The regular meeting of the Port of Iberia District Board of Commissioners was called to order by Commissioner Roy A. Pontiff, Board Vice-President, at the Port of Iberia Administrative Office, on Tuesday, April 20, 2021, at 5:30 P.M.

In attendance were Commissioners Roy A. Pontiff, Vice-President, Shane Walet, Secretary – Treasurer, Simieon d. Theodile, and Patrick Broussard.

Commissioners Danny J. David, Sr., President, Elbridge "Smitty" Smith, III, and Mark Dore' were absent.

Also present were Craig Romero, Executive Director, Joanna Durke, Administrative Assistant, Tracy Boudreaux, Bookkeeper-Secretary, Shari Landry, Secretary-Receptionist, and Ray Allain, Port Attorney.

Commissioner Roy A. Pontiff requested a moment of silence for the crewmembers aboard the Seacor Power vessel that capsized on Tuesday, April 13, 2021.

Thus, with a quorum being acknowledged, Commissioner Shane Walet recited the opening prayer and the Pledge of Allegiance.

- I. APPROVAL OF MINUTES Regular Meeting Wednesday, March 24, 2021.

 - Special Meeting Thursday, April 8, 2021.
 - Commissioner Roy A. Pontiff stated that all Minutes will be tabled until the May Monthly Board Meeting.

II. DISCUSS AND/OR DISTRIBUTE THE FOLLOWING:

- (a) Budget Summary for Nine (9) Month Ending March 2021.
- (b) Listing of Utility Breakdown as it Relates to Electricity, Water, & Natural Gas.

- Mrs. Joanna Durke stated that Diversified Materials, LLC is unable to pay their rent.
- Commissioner Roy A. Pontiff stated that the Board will give Mr. Craig Romero the

- next 30 days to get with Matt Durand of Diversified Materials, LLC and at the May Board Meeting the Board will consider the legal action that needs to be taken.
- Mrs. Joanna Durke stated that Parker Drilling, Inc. balance is the deferred payment for January 2021 thru June 2021.
- Mrs. Joanna Durke stated that Crosby Construction Services, Inc. did pay half of the rent, the other half was due on March 31, 2021. She will get with them again being it is time to invoice them for the next Six (6) months.
 - > Dynamic Industries, Inc. March 26, 2021 Letter Regarding Tracts "A", "C", "E", "E-1", and "G" at the Port of Iberia.
- Mrs. Joanna Durke stated that this is Dynamic Industries, Inc. letter stating they are vacating the property on April 30th. She was working on a lease cancellation but this letter will suffice as their lease cancellation.

III. RATIFICATION OF RENEWAL OF CERTIFICATE OF DEPOSIT.

A motion was made by Commissioner Shane Walet, seconded by Commissioner Patrick Broussard, to approve and ratify the renewal of Certificate of Deposit Number 42001135300 which matured on March 24, 2021, with Iberia Bank, for twelve (12) months at the rate of 0.10% and 0.10% A.P.Y., for the Louisiana Machinery/WPS Security Deposit, in accordance with the Lease Agreement with the Port of Iberia District.

IV. MR. HAROLD SCHOEFFLER TO ADDRESS THE BOARD REGARDING WIND ENERGY.

- Mr. Harold Schoeffler introduced Public Service Commissioner, Mr. Mike Francis.
- Mr. Harold Schoeffler stated that he spoke with other Ports concerning wind energy and the most favorable response he received was from the Port of Iberia.
- Mr. Harold Schoeffler discussed the different factors of Wind Energy, which are; Air density, Turbulence, Sheer (difference between top of blade & bottom of blade), Timing (most critical factor), and Wind Resource.
- The state that has the most premier sites than the rest of the country is Louisiana.
- Mr. Harold Schoeffler stated that shallow waters are less costly for wind energy.
 Louisiana bays are shallow water making them a good place.
- Mr. Harold Schoeffler stated that the big issue here is what impact it would have on the Port. The concrete barges would be fabricated at the Port of Iberia. Concrete barges would be made out of a mold. Concrete barges require less maintenance and are less costly.
- Mr. Harold Schoeffler stated that the European Model for offshore wind energy states that 10 jobs are produced per mega watt. The Port would have 300 mega watts.
- Public Service Commissioner, Mike Francis stated that the electricity generated will be sold to someone. State law states that you can't sell electricity in Louisiana without the Public Service Commissions guidance. The Port of Iberia will have to have a Power Purchase Agreement.
- Mr. Mike Francis thinks this would be a big benefit to this area. He believes this would be very cost effective.
- Mr. Mike Francis stated that the next step would be to meet with a company that is experts in wind energy to help with research and then the fabrication facility.
- Commissioner Simieon d. Theodile stated this is a huge opportunity and is a game changer for the Iberia Parish area.

V. MR. TODD VINCENT, PRESIDENT & CEO, SELLERS AND ASSOCIATES, INC. TO ADDRESS THE BOARD REGARDING A PRESENTATION ON FLOOD PROTECTION.

- Mr. Todd Vincent stated that they have designed & built Six (6) structures around public buildings, some examples are; Erath High School, Dozier Elementary, 7th Ward Elementary, and Vermilion Parish Detention Center.
- The structures were made from a concrete wall and earthen berm.
- These projects were funded by FEMA Hazard Mitigation Grant money.
- Mr. Todd Vincent stated that FEMA also has a non disaster program which is a

- annual program that is funded by congress, Building Resilient Infrastructure and Communities grant (BRIC). This is annually funded. In 2020 it was funded \$500,000,000.00. The application period is from September January yearly.
- Mr. Todd Vincent stated that the cost estimate for the Port of Iberia office and also the Sheriff's Office would be between \$2.0 to \$2.5 million.
- Mr. Todd Vincent stated that the Port would need to go through a procurement process to hire an engineer and grant manager for this project.
- Mr. Todd Vincent stated that based on the budget with FEMA doing 75% and local doing 25%, the Port's share would be \$625,000.00 for both structures.
- Mr. Todd Vincent stated that if the Port would want to expedite the process, the Port's share would increase to \$865,000.00.
- Mr. Todd Vincent stated that a pumpstation would need to be inside of the system along with a backup generator.
- Mr. Todd Vincent stated that the wall height he recommends for the Port Office would be around Five (5) feet tall and the wall for the Sheriff's Office would be around Seven (7) feet tall.
- Commissioner Roy A. Pontiff stated that the Board will take this under advisement, he recommended possibly having a committee meeting.
- VI. MR. BRAD CRADEUR, INTERIM DIRECTOR, IBERIA PARISH SEWERAGE DISTRICT NUMBER 1, TO ADDRESS THE BOARD REGARDING THE OPERATION AND MAINTENANCE BUDGET FOR SEWERAGE SERVICES PROVIDED BY SEWERAGE DISTRICT NUMBER 1 TO THE PORT OF IBERIA.

The above item was pulled off of the Agenda.

- VII. REPORT FROM MRS. CARMEL BREAUX, PRESIDENT, NORRIS INSURANCE CONSULTANTS, INC., REGARDING THE PORT OF IBERIA DISTRICT'S 2021 ANNUAL INSURANCE RENEWALS AND REQUEST FOR PROPOSALS:
 - {1} (May 12, 2021 Renewal): General Liability, Automobile Liability and Physical Damage, Umbrella Liability, Public Official Errors & Omissions Liability, Crime, Boiler & Machinery, Inland Marine, Equipment Floater and Building & Contents.
 - Mrs. Carmel Breaux stated that she was asked to get a flood quote on Seadrill's building. She stated that she asked Brown & Brown to quote the maximum of \$500,000 and to do at maximum deductible which is \$50,000, the premium would be \$13,744.00.
 - Mrs. Carmel Breaux stated that she had conversations with Mr. Craig Romero and Mr. Gerald Gesser asking if they would really need to put a flood policy on
 - Mrs. Carmel Breaux stated that the Port would mainly incur clean up if mud would

- get in the building.
- Mr. Craig Romero stated that there is not a reason to put flood insurance on the building.
- Mrs. Carmel Breaux stated that this quote was strictly for the Board's information.
 She is not recommending this gets done tonight.
- Mrs. Carmel Breaux discussed the general liability, Errors & Ommissions, Crime, and Building and contents policies, these come up for renewal on May 12, 2021.
 Mrs. Carmel Breaux stated that she began the RFP process in February, the proposals were due at the Port Office on April 6th. One of the Two agents only quoted the general liability, errors & ommissions, and crime, they did not quote property. Mrs. Carmel Breaux stated that the other agent quoted general liability, crime, and building and contents, they did not quote errors & ommissions.
- Mrs. Carmel Breaux stated that she spoke with Mr. Craig Romero and made the
 decision to name an agent of record and let them go back to the market to build a
 program that would be affordable to the Port. The agent is Brown & Brown.
- Mrs. Carmel Breaux stated that the Port has buildings that they would like to remove from the statement of values and later demolish the buildings. She stated that the only problem with this is if the Port collected FEMA funding in the past claiming wind or flood, the Port has a Obtain & Maintain agreement with FEMA concerning those buildings. She stated that this means the Port has to carry wind or flood coverage on the buildings at all times. Mrs. Carmel Breaux is only concerned that if the Port does go through with taking the buildings off the statement of values that the Port would not be able to file flood claims in the future on that property or in general on all Port properties.
- Mrs. Carmel Breaux stated that she has contacted flood experts and FEMA. She is currently awaiting their feedback.
- Mrs. Carmel Breaux stated that FEMA does have money available for claims on a building that the owner wants to demolish the building rather than repair. The owner can apply for demolition dollars and FEMA normally approves this.

(April 1, 2021 Renewal): Flood Insurance; Worker's Compensation.

 Mrs. Carmel Breaux, President, Norris Insurance Consultants, Inc., presented a flood spreadsheet to the Board with Three (3) locations high lighted that are due for renewal on May 26, 2021. Mrs. Carmel Breaux recommended the Board approves to renew these Three (3) flood policies.

A motion was made by Commissioner Patrick Broussard, seconded by Commissioner Shane Walet to approve and authorize the Port's 2021 Annual Renewal of Flood Premium's for Logan Industries, Ram Design, and Sheriff Office as

presented.

(a) Hold Harmless Agreement Regarding ARL and Seadrill that will Allow Seadrill to Occupy Certain Areas of Building B to Commence their Lease Period.

- Mr. Ray Allain stated that initially he thought there had to be different agreements for Multipurpose Building B & Building B Bay 5. Mr. Ray stated that the agreements would be the same thing so he combined them into one. This is an agreement between the Port of Iberia District, Seadrill Americas, Inc., Acadiane Renovations, Ltd., and GIS Engineering, LLC.
- Mr. Craig Romero stated that Seadrill is ready to occupy the facility and Mr. Oneil Malbrough stated that Acadiane Renovations is asking to allow them to drop their builders risk insurance. He read the contract and did not see this in the contract.
- Mr. Oneil stated that Acadiane Renovations' Attorney can explain to the Port that
 they can drop their builders risk insurance as soon as the building is substantially
 complete. Mr. Oneil stated that the contract reads all insurance has to be maintaind
 by the contractor until all of the work is performed that is in the contract, this inludes
 the punchlist.
- Mrs. Joanna Durke stated that she spoke with LA DOTD and was told that this cannot be done until the contractor has a clear lien certificate and the project has been accepted.
- Mr. Oneil stated that Acadiane Renovations is wanting to drop the builders risk insurance for Cranes & Ventilation. The ordering of the flood vents was pushed back longer than they expected with Hurricane Season arriving.
- Mrs. Joanna Durke stated that LA DOTD has stated they have never had this happen before.
- Mr. Oneil Malbrough asked if the Port could allow a tenant to move into the facility with the contractor not signing the substantial completion.
- Port Attorney, Ray Allain, stated that the Port has to have appropriate property insurance and liability insurance, and also the Port will need Seadrill's Endorsement of Insurance before they occupy the facility. Mr. Ray Allain also stated that if the Port approves the Agreement the Port has to get the insurance, the contractor to sign the substantial completion, and insurance verification from Seadril before they occupy.
- Mrs. Joanna Durke stated that the Port does not have Property Insurance yet on this facility, this will be determined at the tentative Special Meeting on May 4th.
- Commissioner Roy Pontiff questioned Seadrill's payment on June 1st. Mr. Craig Romero stated that Seadrill set up a purchase order number for the amount from June to December, once a month they will wire the money due for rent.
- Mr. Craig Romero stated that there is nothing in the contract that states Seadrill needs to pay in one lump sum. He also stated that Seadrill's system is set up to pay monthly.
- Commissioner Roy Pontiff indicated that it is in the Contract.
- The Port Attorney went over the Seadrill Lease Agreement.
- Commissioner Roy Pontiff stated that they might need to amend their lease.
- Mr. Craig Romero stated that he will invite them to the next Board Meeting.

- Mr. Ray Allain stated that the Board can approve the Agreement contingent upon Seadrill paying the rent as stated in the lease.
- Mr. Ray Allain stated to approve the Agreement contingent upon Acadiane Renovations, Ltd. signing the Substantial Completion and contingent upon Seadrill agreeing to pay the rent as provided in the Lease Agreement.
- Commissioner Roy Pontiff recommended approving the Agreement contingent upon Seadrill paying the lease rent stated in the Lease Agreement with the Port of Iberia District unless bankruptcy requires the bills be paid monthly or other method.
- The current invoice for Seadrill Americas, Inc. still stands as is. Commissioner Roy Pontiff stated that if they cannot pay the full amount, they must come back with a plan to present to the Board before they occupy the facility.
