# PORT OF IBERIA DISTRICT BOARD OF COMMISSIONERS REGULAR MEETING - TUESDAY, JULY 19, 2016 PORT ADMINISTRATIVE OFFICE - 5:30 P.M. MINUTES

The regular meeting of the Port of Iberia District Board of Commissioners was called to order by Commissioner Larry G. Rader, Board President, at the Port of Iberia Administrative Office, on Tuesday, July 19, 2016, at 5:38 P.M.

III. Mr. Creed Romano, Site Development Program Manager, Louisiana Economic Development (LED), to address the Board regarding available property for prospects.

Mr. Creed Romano gave the Board a background of how he secured the position he has now. Mr. Romano spoke about the two parcels the Port has available for development (50 acre site and 30 acre site). The two sites are not on the work plan. This meaning there has not been a pre-application filed to have the land considered for inclusion into the Certified Site Program. One of the requirements for certification is you have 25 continuous buildable acres above the 100 year flood plain. Mr. Romano said the base flood elevation he looked at for the sites will be a challenge; however it is their goal to have at least one certified site in every parish. The Bayou Region has been a very challenging region, as far as, there has not been a lot of interest. Mr. Romano indicated what his team and he would like to work with members of the community in the Parish to try to identify a site and/or sites that the Port of Iberia District thinks would have the best chance to make it through the program. Mr. Romano indicated in agricultural regions, if you have a site that is available but it is in agriculture production, he would suggest looking at the service lease regarding the tenant farmer and let the farmer know if you have a prospect that is interested in the site, and the Port could work with the farmer. Companies want to move extremely quickly when they are looking for sites. The more you can do to make your site more attractive/marketable the better chance it has.

Board President Larry Rader asked Mr. Romano if LED has any kind of assistance in helping to get the site ready. Mr. Romano reported they do have a program. Louisiana is the only State in the United States that offers a program of such. The program is a cost sharing program; which means once a site has been approved, the preapplication phase in order to proceed further down the line is eligible for funding which then means Mr. Romano's program picks up 75% of the cost associated with certification. The local organization is responsible for the remaining 25%. Mr. Romano gave an example of

another company in Lake Charles where Cleco picked up the remaining 25% for a company.

Port Commissioner Danny J. David, Sr. asked Mr. Romano if access plays an important part of the program (rail, water, road, and air). Mr. Romano indicated the better logistics that you have to the site makes it so much more attractive. Discussion ensued and there was no action taken.
