PORT OF IBERIA DISTRICT BOARD OF COMMISSIONERS REGULAR MEETING - TUESDAY, NOVEMBER 15, 2016 PORT ADMINISTRATIVE OFFICE - 5:30 P.M. MINUTES

The regular meeting of the Port of Iberia District Board of Commissioners was called to order by Commissioner Gene L. Jefferies, Vice-President, at the Port of Iberia Administrative Office, on Tuesday, November 15, 2016, at 5:37 P.M.

III. MR. WILLIAM A. CENAC, II, PE, S&ME, INC., TO ADDRESS THE BOARD.

Mr. William A. Cenac, II, PC with S&ME, Inc. stated S&ME was founded in 1973 in Raleigh, North Carolina. They provide soil and material engineering services. Through strategic growth and acquisition they are now a 1,100 person firm, employee owned, with 35 locations throughout the East coast and US. They also provide transportation, energy, construction, environmental, geotech, and civil design services. In 2014, a Lafayette office was opened providing coastal services as related to geotechnical design and the coastal environment, coastal engineering, and environmental services relating to the coast.

IV. MR. TED JOHNSON, CUSTOMER SERVICE REPRESENTATIVE, ENTERGY, TO ADDRESS THE BOARD RELATIVE TO DISCUSSING/CONSIDERING APPROVING A RIGHT-OF-WAY INSTRUMENT TO RELOCATE AN ELECTRICAL DISTRIBUTION FACILITY.

Mr. Ted Johnson, Customer Service Representative, Entergy, reported Entergy would like to build a new distribution line to relocate the existing line that runs through the woods behind the Port. It is inaccessible and has caused problems in the past. Mr. Ted Johnson reported a couple weeks ago a tree fell on the line and it took about 7 hours to get the power back on. Had he had the line built at the time there would have never been an outage. It will greatly improve the power quality and reliability to the Port. The project is about a \$67,000.00 project at no cost to the Port. The line and the right of way will fall inside an existing transmission right of way. No additional properties will be needed in the right of way. The reason he is asking for a distribution is because the existing right of way is transmission and they are distribution so they have to get their own right of way. There will be a bore underneath the channel. The transmission lines (overhead lines) will stay. Commissioner Roy A. Pontiff asked Mr. Ted Johnson how deep will the underground lines be and Mr. Ted Johnson reported he wasn't able to answer the question. Commissioner Roy A. Pontiff stated the Port requires 24 ft. below the bottom. Mr. Ted Johnson reported the job has already been staked and he would like to get the project done this year. Executive Director Craig Romero stated Entergy is accessing some grant money and if they don't get the project done in the time frame then Entergy will lose the opportunity. Port Attorney Ray Allain expressed his concerns regarding the exact path and what is it going to occupy. Port Attorney Ray Allain stated he had spoken to Mr. Ted Johnson and this is being built in an existing transmission right of way and that transmission right of way is 120 ft. The distribution right of way Entergy is asking for is 30 ft. so it is within the 120 ft. existing transmission right of way.

The other concern Port Attorney Ray Allain had was related to depicting the exact location. He stated it is important that we have something very specific that can be attached to the right of way and be recorded. Port Attorney Ray Allain stated where it is being constructed we usually get a survey when Cleco does right of ways and other utility companies give us a survey. In addition to a survey or something very specifically depicting the exact location and some additional language that guarantees the depth of the line going under the channel will be the required depth in view of the timing, Port Attorney recommended to the Commission to authorize the Board President to sign the right of way pending legal review.

When the drawing was done it was specified a heavy duty load rating for the tops because of the industrial nature of the property. The manufacture messed up when he built them. They have been working with the manufacturer and the
