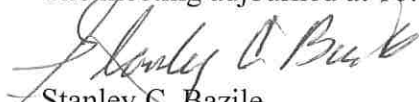

Following the recent meetings and agreements between Kostmayer, WSP and The Port of South Louisiana, we are pleased to submit the proposal outlined below. With over 40 years of experience in marine and heavy civil construction, Kostmayer is fully equipped to manage complex project requirements. Our team is committed to upholding the highest standards of safety, environmental compliance, and industry's best practices to deliver a safe, high-quality result.

Included below are detailed clarifications, exceptions, and scope-related information for your review. This proposal and the associated estimated expenditures are being submitted in support of the Port of South Louisiana's Change Order request.

Port Improvements - Reserve Grain Facility Under Dock Refurbishment – Phase 1A

- **Construction Services**

○ High River Mitigation Efforts	\$250,000 Fixed Price
○ Contingency (To Be Approved by PoSL)	\$ 50,000

Total Change Order Value	\$300,000

- **Scope, Terms and Conditions**

- Kostmayer proposes to construct an elevated rock roadway, approx. 30' wide and up to EL. (+) 16.0' to allow for a higher platform for the land-based crane to continue work.
- The above work can begin once river level reached the EL. (+)16 and falling at the jobsite. Kostmayer will monitor site conditions and river level in the interim to ensure work begins immediately once the river allows.
- If the current MS River Levels projection remains unchanged, work should begin around May 18, 2025, however we cannot guarantee this date and the actual start date will be dictated by actual river levels onsite.
- If the river remains above the EL. (+)16.0 at the jobsite, contract time will remain suspended until it reaches the necessary height.
- As part of this agreement, Kostmayer to provide a crane barge, of similar capacity and size, to facilitate the movement of equipment/supplier onto the ADM dock, until such time that the land based crane can be used in a similar capacity. Once the land based crane can move equipment/supplies for ADM, the crane barge will demobilize.

- Kostmayer will require 75 additional contract days, commencing when the river reaches the level of EL (+)16.0' at the jobsite. Once pre-cast panels and guardrails are complete, the approachway will be available for ADM use. Some items will still be required to be completed after the 75 Day period. (i.e. Guardshack/fencing, electrical, rock removal/final grading)
- Weather Days will be recorded and extension requests of the 75-day period in accordance with Section 8.07 of the Contract.
