# 6a. Award of VLS Office Building Construction Contract to Keiland Construction, LLC In

Trey Case made a motion to award the Construction Contract to Keiland Construction, LLC for the new VLS office building for the amount of their total base bid of \$2,997,000 contingent upon the consent of CSRS and FEMA, 2<sup>nd</sup> by Tim Dougherty. No opposition. Motion carried.

#### 7. Review and approve external audit of West Calcasieu Port.

Darla Perry reported that Steve Derouen, CPA, completed the external audit and the port received a fair opinion with a clean report.

### 12. Port Director Report; Announcements/Reports (Legal, Financial, Engineer)

- **a. Port Director:** Port Director Lynn Hohensee stated that he had nothing to add to his written report at this time.
- **b.** Engineer: Chuck Stutes reported that the bulkhead/crane pad project was going well. It is 88% complete and should be completed in April.

The West Barge Basin dredging contract was awarded, but hasn't started yet. They will be issuing a notice to proceed.

The next project that's coming is the dredging of the area in front of the bulkhead and crane pad which is a DOTD funded project. They are currently waiting on a revised hydrographic surveys on that area. Based on a conversation with the DOTD personnel, they have agreed to allow dredging of the East Barge Basin in the project already funded.

**c. Financial:** Darla Perry reported that July - January the port took in \$1,011,315 and expended \$895,379. The port is 1,502 ahead on barge days over last year. There was no ramp revenue for the month.

She also reported they are expecting \$900,000 from EDA this week.

**d.** Legal: There was no legal report at this time.

After a brief discussion, a motion was made by Trey Case to accept the Port Director, Financial, Engineer, and Legal reports as presented, 2<sup>nd</sup> by Tim Dougherty. No opposition. Motion carried.
