## SOUTHEAST LOUISIANA FLOOD PROTECTION AUTHORITY – WEST (SLFPA-W) Administration Committee Meeting Tuesday, December 5, 2023

The Administration Committee of the SLFPA-W met Tuesday, December 5, 2023, with the following members present: Mr. Gauthé, Chairman, Mr. Fogle, and Ms. Foster.

Mr. Gauthé called the meeting to order in the SLFPA–W Office Commissioners' Room, 7001 River Road, Marrero, Louisiana at approximately 3:30 P.M.

It was moved by Mr. Gauthé and seconded by Ms. Foster to approve the agenda as presented.

There were no public comments.

Mr. Noel briefed the Committee on the quotes for the Harvey Canal Complex sediment removal. Mr. Noel will present the Board with the proposed HNTB task orders at the December 12, 2023 regular board meeting for their consideration and approval.

Mr. Gauthé reviewed the proposed 2024 Board and Committee schedules. The proposed 2024 Board and Committee schedules will be a motion for approval at the December 12, 2023 regular board meeting.

Mr. Bosch updated the Committee on current staffing and open positions. The Committee will continue to be updated.
