The Finance, Administration, Legal and Public Information (FALPI) Committee of the SLFPA-W met Tuesday, February 9, 2021, with the following members present in person: Mr. Gauthé, Chairman, and Ms. Foster. Mr. Burke attended by teleconference.

Mr. Gauthé called the meeting/teleconference to order in the SLFPA–W Office Board Room, 7001 River Road, Marrero, Louisiana at approximately 3:30 P.M.
