The Finance, Administration, Legal and Public Information (FALPI) Committee of the SLFPA-W met Tuesday, April 13, 2021, with the following members present in person: Mr. Gauthé, Chairman, and Mr. Burke. Ms. Foster attended by teleconference.

Mr. Gauthé called the meeting/teleconference to order in the SLFPA-W Office Commissioners' Room, 7001 River Road, Marrero, Louisiana at approximately 3:30 P.M.

It was moved by Mr. Gauthé and seconded by Mr. Burke to approve the agenda as presented.

There were no public comments.
