Finance, Administration, Legal and Public Information Committee Meeting  
Tuesday, October 8, 2019

The Finance, Administration, Legal and Public Information (FALPI) Committee of the SLFPA-W met on Tuesday, October 8, 2019, with the following members present: Mr. Gauthé, Chairman, Mr. Burke and Mr. Gaddy.

Mr. Gauthé called the meeting to order in the Commissioners' meeting room at the SLFPA-W Office, 7001 River Road, Marrero, Louisiana at approximately 3:30 P.M.

It was moved by Mr. Gaddy and seconded by Mr. Burke to approve the agenda as presented.

There were no public comments.

It was moved by Mr. Gaddy and seconded by Mr. Burke to approve the minutes from the previous meeting dated September 10, 2019.

It was moved by Mr. Gaddy and seconded by Mr. Burke to enter executive session. The Committee entered executive session at approximately 3:31 P.M. Mr. Pickering provided an update on two cases:

- a. All State Financial Company, Advance Mortgage Company LLC vs WJLD, SLFPA-W, Board of Commissioners of the SLFPA-W, No. 793-729, 24th Judicial District Court, Jefferson Parish.
- b. Terry Bordlee vs. SLFPA-W et al, U.S. District Court for the Eastern District of Louisiana No.19-cv-9817.

It was moved by Mr. Gaddy and seconded by Mr. Burke to exit executive session. The Committee exited executive session at approximately 3:49 P.M. No action was taken.

Mr. Bosch and Ms. Ledbetter presented the check register for SLFPA-W, West Jefferson Levee District and Algiers Levee District. The Committee will recommend the check register for approval by the Board.

Mr. Bosch and Ms. Ledbetter provided an update on the current budget. They will continue to update the Committee.

Mr. Bosch updated the Committee on the financial statements for SLFPA-W, West Jefferson Levee District and Algiers Levee District.

The Committee reviewed and approved the Commissioners' expense reports for payment.

Mr. Monzon and Mr. Cali presented the AFE for an in kind fuel truck to the Committee. It was moved by Mr. Gaddy and seconded by Mr. Burke and unanimously approved to endorse the purchase of a replacement fuel truck for \$86,360.00.

Mr. Monzon and Mr. Cali presented the AFE for purchase of three John Deere 5115M tractors. It was moved by Mr. Gaddy and seconded by Mr. Burke and unanimously approved to endorse the purchase of three John Deere 5115M tractors for total of \$184,615.00.

Mr. Cali presented the AFE for purchase of three John Deere R15 cutting decks. It was moved by Mr. Gaddy and seconded by Mr. Burke and unanimously approved to endorse the purchase of three John Deere R15 cutting decks for total of \$64,215.00.

Mr. Monzon provided a Director's report of his activities for the month of October and informed the Committee of pending issues.
