## SOUTHEAST LOUISIANA FLOOD PROTECTION AUTHORITY – WEST (SLFPA-W) Minutes of the Regular Board Meeting Tuesday, May 24, 2022

The SLFPA-W Board of Commissioners met at approximately 4:00 P.M. Tuesday, May 24, 2022 at the Moreau Center, MC Conference Room at the University of Holy Cross, 4123 Woodland Drive, Algiers.
