

SOUTHEAST LOUISIANA FLOOD PROTECTION AUTHORITY – WEST (SLFPA-W)  
Finance, Administration, Legal and Public Information Committee Meeting  
Tuesday, February 6, 2018

The Finance, Administration, Legal and Public Information (FALPI) Committee of the SLFPA-W met on Tuesday, February 6, 2018 with the following members present: Mr. Burke, chairman, and Mr. Thomas. Ms. Maclay arrived at 6:11 P.M.

Mr. Burke called the meeting to order in the Commissioners' meeting room at the SLFPA-W Office, 7001 River Road, Marrero, Louisiana at approximately 6:00 P.M.

It was moved by Mr. Thomas, seconded by Mr. Burke and unanimously carried by the members in attendance to approve the agenda as presented.
