## SOUTHEAST LOUISIANA FLOOD PROTECTION AUTHORITY – WEST (SLFPA-W) Technical, Operations and Maintenance Committee Meeting Tuesday, June 8, 2021

The Technical, Operations and Maintenance (TOM) Committee of the SLFPA-W met Tuesday, June 8, 2021, with the following members present: Mr. Julien, Chairman, and Mr. Robinson. Mr. Thomas was absent.
