 District is interested in the stockpile for the Mississippi River Levees (MRL) Duncan Point Seepage
 Control, EBR Parish, La.
- The American Construction Demolishing Company is in process of demolishing the structure at 18851 Plank Road, Zachary, Louisiana.

6. ARBC Legal Counsel Report - Old Business
