- I. Call to Order and Welcome The meeting was called to order at 11:00am by Chair Mary Lee.
 - Mary Lee introduced guests.
- II. **Approval of Minutes**: Minutes from the previous meeting were approved. Adam Holland motioned to approve. Joy Pace second. Motion approved.
- III. LSAC Chair Report: Mary Lee welcomed everyone.
 - Mary reported on the South Arts Fellowship Awards held recently in New Orleans, indicating that LDOA serves as a sponsor.
 - Gene Meneray provided a schedule update on the Artist as Entrepreneur Boot Camps.
 Gena Gore indicated that LSAC members had not been provided an updated lists of dates. Cheryl stated that she would send these. Gene indicated that all dates were scheduled except for Natchitoches. Will send that date as soon as they respond.

V. LDOA Director's Report:

Cheryl presented this year's NEA Award:

Grant Amount: \$745,500, which consists of the following components:

\$587,100 for Plan, including \$17,500 for Poetry Out Loud \$29,400 for Arts Education \$106,000 for Underserved Communities \$23,000 for Folk Arts Partnership

- LDOA awarded 22 \$500 Musician Mini-Grants. The process went smooth. The applicants were from various parts of the state representing a variety of musical genres. For FY19 LDOA may look at doing two mini-grants focused on two different artistic genres.
- Paula White provided an update on the new online grant system for DAF and General Operating Support.
- Danny Belanger provided an update on Poetry Out Loud and Accessibility Efforts in identifying Veterans initiatives throughout the state. He has also been working with the Governor's Office on Disability Affairs to provide better access to the arts throughout the state.
- Maida Owens discussed the completion of the current phase of the Baton Rouge Traditions project.
