The regular monthly meeting of the Bayou Lafourche Fresh Water District was held on Tuesday, May 26, 2020 at 4:00 p.m. via teleconference.

Vice-Chairman Gene Harrell began the meeting at 4:00 pm.

Moved by Commissioner Jake Giardina, seconded by Commissioner Ray Mayet to dispense with the reading of the minutes, and approve the minutes of April 29, 2020. Motion carried unanimously.

Moved by Commissioner Eli Miles, Jr., seconded by Commissioner Francis Richard to approve the accounts payable for April. Motion carried unanimously.

Moved by Commissioner Francis Richard, seconded by Commissioner Jake Giardina to approve the finance report for April. Motion carried unanimously.

Mr. Ben Malbrough reported that we are still fully siphoning at the Pump Station and taking the necessary precautions to disinfect, for employee safety.

Mr. Malbrough reported that the Bayou crew employees are back and working to catch up on spraying the water hyacinths and removing downed trees in the bayou.

Mr. Malbrough reported the updates to the Pump Capacity Improvements Project (PCIP). The responses to USACE relating to the Archaeological and Architectural report that was submitted to the USACE has been finalized. We are waiting on the State Historic Preservation Office to issue the identification number for the existing pump station because it is a historical structure. Once that number is received, we will be able to formally submit our responses. We are hopeful that USACE can then complete their review again within 2 or 3 weeks.

Mr. Malbrough reported the progress on the North Water Control Structure Project. There will be a meeting onsite with the Contractor and the Engineer to find a resolution to an issue that has come up with the gate. The scheduled completion date should not be affected and should still be finished early June.

Mr. Malbrough discussed the progress on the Weir Removal Project. We have received our Coastal Use Permit Authorization as well as our USACE permit. Therefore, from a regulatory standpoint, we are set to move forward once we receive the substantial completion on the North Water Control Structure. Then we can go to bid.

Mr. Malbrough discussed the Sediment Trap Maintenance Dredging Project. After surveying, it is to the point now where it needs to be dredged. Delta Coast has completed the plans and specifications for the project, and it is now ready to go out for bid.

Mr. Malbrough asked the Board for authorization to go out for bid on the Sediment Trap Maintenance Dredging Project. The engineers estimate for the completion of the project is about \$250,000.00.

Moved by Commissioner Barry Soudelier, seconded by Commissioner Eli Miles, Jr. for authorization to go out for bid on the Sediment Trap Maintenance Dredging Project. Motion carried unanimously.

Mr. Malbrough discussed the proposals from Millage Management, LLC to manage the millage renewal for the 2020 Tax Year (Reassessment).

Mr. Malbrough asked the board to approve the proposals from Millage Management, LLC - Multi-Parish proposal for \$3,800.00 and Terrebonne Parish proposal for \$3,200.00.
