Minutes  
September 27, 2024

Members Present: Allen Blanchard, Loyd Dodson, Mike Kovak, Nickey Smith, Johnathan Lopinto and Jarett Daigle

Mike Kovac was sworn in as the representative for the Cattlemen's Producers of Louisiana.

Election of Officers:

Loyd Dodson made a motion, seconded by Nickey Smith to nominate Allen Blanchard as Chairman of the LBIC. The motion passed unanimously.

Jarret Daigle made a motion, seconded by Loyd Dodson to nominate Nickey Smith as Vice-Chairman. The motion passed unanimously.

Loyd Dodson made a motion, seconded by to nominate Jarett Daigle as Secretary/Treasurer. The motion passed unanimously.

John Thompson suggested adding an attendance policy. This will have to be brought to the next legislative session if the Council agrees to adopt an attendance policy to be written in to statute. The Council agreed to add this discussion to the December meeting agenda.

Financial Report:

The Council next discussed the Local Agriculture Market Program (LAMP).

Funding Requests:

Bryan Churchman, Vernon Parish Cattlemen's Association, gave a report on the 2023 VCPA's Senior Citizen Day and Youth Ag Day. The 10th annual Vernon Parish Cattlemen Youth Ag Day event took place on October 4, 2023 at the Porter and Sons Ranch in Leesville, LA. Over 150 students along with teachers, administrators, and councilors from eight parish high schools, one private high school and home-schooled students for a day in the life of a cattle ranch. Education was the focus, and the students were divided into five groups and received instruction on the following topics: Farm safety, ATV/Farm Equipment, careers in agriculture, animal health, beef

quality assurance, USDA (FSA) (NRCS) and drone applications. The 2023 Vernon Parish Senior Citizen Day fed over 800 senior members of the community and red meat was the main course. Beef recipes were also provided to the participants. A request was submitted to fund the 2024 Senior Citizen and Youth Ag Day. A motion was made by Jarrett Daigle, seconded by Loyd Dodson to approve this project for the amount of \$2,500.00. A roll call vote was taken.
