This sponsorship will promote beef by being featured as an entree on custom printed menus, table tents, check presenters, city-wide digital billboards, features on WAFB & BR Proud, features on Guaranty Broadcasting, 25,000+ fans and followers on social media, 20,000+ daily emails subscribers menus featured on digbr.com, eatbr.com, wafb.com, Opentable, and visitbr.com, over 1 million page views during event month and a \$2 donation per social media post with #eatbr given to the Greater Baton Rouge Food Bank. Loyd Dodson made a motion, seconded by Nickey Smith to approve the sponsorship of Restaurant Week for the amount of \$10,000.00. A roll call vote was taken. Jeff Florence, Federation of State Beef Councils, gave an update on the final results of the digital Southeastern States Campaign. This campaign promoted the 2021 summer grilling season Memorial Day through Labor Day. Digital advertisements ran on YouTube, Spotify and Google. The final campaign had over 10 million engagements (video views, audio listens and clicks).

Skyler Lenz, also with the Federation of State Beef Councils, presented the final report of the 2021 LBIC Digital Media Campaign running through 05/31/2021 - 09/10/2021. This campaign

objective is to maximize the awareness of the *Beef. It's What's For Dinner*. brand and promote summer grilling across the state of Louisiana using a mix of the newly-created national summer grilling assets and always-on recipe content through YouTube, Spotify and Google Search. The final campaign results are as follows: YouTube impressions: 1,756,761 and 1,196,004 video views, Spotify: 333,101 impressions and 304,613 audio listens and Google: 103,890 impressions.

A link was sent to the Council which was a local news story showcasing the success of the October 6 Vernon Parish Youth Day. The purpose of Youth Day is to educate students about what it takes to raise the food that is on their table.

Vendal Fairchild gave a report on the 2021 State Fair. This event took place on October 28 – November 14 in Shreveport, LA.

The 2021 Fall Associated Grocer's show was cancelled due to COVID-19. Discussion took place regarding the 2022 Spring show.

The Ag Expo is still set to take place on January 14-15, 2022 at the Ike Hamilton Expo Center in West Monroe, LA. Council members are asked to man the LBIC booth at Ag Expo.

The Louisiana Department of Agriculture and Forestry approved the promotional grant for the amount of \$12,500.00. This grant will be used towards the Louisiana Radio Network campaign in the summer of 2022.
