### **Revision to the Incident Reports to the Board**

Capt. Brown gave a report to the Board regarding the addition of an executive summary and a chart to supplement the current Incident Report form. The purpose of the executive summary is to give a brief overview of the incident and the chart is provided to see where the incident occurred. Final determination of the incident is reported in the Quarterly Meeting minutes of the NOBRA Board of Examiners, which is distributed to the Board.

#### **Incident Report Format**

It was resolved that incidents that occur after May 20, 2010 will conform to the new incident report format and incidents that occurred prior to May 20, 2010 do not have to conform to the new incident report format.

## **Template for the Investigator's Report**

It was resolved that Capt. Steinmuller provide a template for an Investigator's report that can be used to cross reference incident reports with final dispositions.

## Selection of a CPA firm for Audit of the Board
