Bill Hidalgo 1st, Dietmar Rietscher 2nd, no public comment, passed.

- V. Levee Districts' Tax Proposal Ray Fremin discussed the current situation in Iberia, which will go to the ballot this month. A separate coalition was formed to help pass this vision. Bill Hidalgo discussed his levee district and risk involved in going to the ballot. Windell levee districts without funding, you can get private funds, but the O&M is the stopping block even if you can build with grant funding sources. Reggie Dupre: Regional Coalition needed to take policy issues. Chenier Plain Authority Earl Landry/ Nedra Hains: discussed the issues with Chenier Plain Authority. Reggie: discussed the history of the east levee districts and how the reforms happened. Reggie: 2007 Morganza to the Gulf issues discussed, build federal project with no federal funds.
