On Monday May 8, 2023, a hearing was held before the Commissioners of the Louisiana Motor Vehicle Commission (the "Commission") on a complaint that Marler Ford Co., L.L.C. did not have an enclosed new motor vehicle display showroom of not less than 400 square feet in area as required by the Louisiana Administrative Code, Title 46; Professional and Occupational Standards; Part V. Automotive Industry; Subpart 1. Motor Vehicle Commission; Rule 901-Display Showroom Requirement.

After receipt of documentary and testimonial evidence adduced and admitted into evidence at trial of this matter and for reasons orally assigned, the Commission made the following finding of fact and conclusion of law:

FINDING OF FACTS:

Marler Ford Co., L.L.C. possessed an enclosed new motor vehicle display showroom of not less than 400 square feet in area.

CONCLUSION OF LAW:

Marler Ford Co., L.L.C. is not in violation of Title 46; Professional and Occupational Standards; Part V. Automotive Industry; Subpart 1. Motor Vehicle Commission; Rule 901-Display Showroom Requirement.

Considering the forgoing findings of fact and conclusion of law, and pursuant to the authority vested in the Commission as set forth in La. R.S. 32:1251, et seq.:

IT IS ORDERED, ADJUDGED AND DECREED that the complaint against Marler Ford Co., L.L.C. be and is hereby DISMISSED.

LOUISIANA MOTOR VEHICLE COMMISSION

Chairman Lala announced a recess of the LMVC's meeting at 11:32 a.m. in order to conduct hearings related to the Motor Vehicle Sales Finance law.

The LMVC's meeting reconvened at 12:10 p.m.

The Executive Director presented to the Commission Members a mobile service program implemented by Ford Motor Company as an extension of dealership services to provide customers with convenient way to service their vehicles. The Executive Director explained because a Ford dealer had complained regarding another Ford dealership performing a warranty service at an individual's residence in the dealer's area of responsibility. The Executive Director contacted Ford's representative and was advised that the reason Ford Motor Company started a mobile service program was because of excessive recall work that customers were not getting completed at a dealership. The Executive Director asked the Members to clarify whether recall repair performed by a mobile service van is considered as recall repair conducted at a satellite warranty center. After a brief discussion, there is no decision made.

The Executive Director presented to the Commission Members an e-mail from Jay McCalmon, Director of Transformantion and Innovation of Cleco Corporate Holdings LLC, on May 2, 2023, wherein Mr. McClamont informed the Commission that they are hosting an EV Ride and Drive event on May 11, 2023 to May 12, 2023, at Cleco's Pineville General Office, 2023 Donahue Ferry Road, Pineville, Louisiana. The reason for the event is to support electrification adoption and promotion of being the leading clean energy company in Louisiana. This event is hosted in coordination with Louisiana Clean Fuels and Drive Electric Louisiana. These following dealerships had made their request with the Commission for approval to participate int this EV Ride and Drive:

The Executive Director advised there was a few months left in the current year of Counselor LaPeyronnie's two year contract and it would exceed the limits of the contract and requested the following amendment to the contract be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed \$430,000.00 for the period commencing January 12, 2022 and ending on January 11, 2024."
