The Chairman called to order Hearing #2016-043, Redneck Yacht Rentals LLC. for alleged violations of LSA-R.S. 32:1254. A.(10) and LSA-R.S. 32:1261. A.(3)(c). No one from Redneck Yacht Rentals LLC attended the hearing. A court reporter was brought in to record the transcript of the hearing, which will be made a permanent part of the Commission's files. The following Judgment was rendered.

JUDGMENT

This cause came to be heard on Monday, January 9, 2017 before the Louisiana Motor vehicle Commission (the "Commission"). Redneck Yacht Rentals LLC, 1201 Lake Shore Drive, Lake Charles, Louisiana 70601, did not appear at the time of the hearing, having been duly served with notice by Ernest L. Mitchel, Deputy Sheriff of Calcasieu Parish Sheriff's Office.

And after hearing the testimony adduced at trial, the receipt of documentary evidence into the record, and for reasons orally assigned, the Commissioners of the Commission make the following findings of fact and conclusion of law:

Findings of Fact: Redneck Yacht Rentals LLC is operated a marine products leasing and rental business since April of 2014; and

Redneck Yacht Rentals LLC did not, and does not, possess a motor vehicle lessor license issued by the Commission.

Conclusions of Law: By leasing and renting marine products without first possessing a motor vehicle lessor license issued by the Commission, Redneck Yacht Rentals LLC violated LSA-R.S. 32:1254.A.(10) and LSA-R.S. 32:1261.A.(3)(c).

Considering the forgoing and pursuant to the authority vested in the Louisiana Motor Vehicle Commission set forth in LSA-R.S. 32:1251, et seq.:

IT IS ORDERED, ADJUDGED AND DECREED that Redneck Yacht Rentals LLC immediately cease engaging in the marine products rental business until such time as Redneck Yacht Rentals LLC obtains a motor vehicle lessor license issued by the Commission for the current and the three (3) years immediately prior thereto, and also pays all fees and late fees associated therewith;

IT IS ORDERED, ADJUDGED AND DECREED that Redneck Yacht Rentals LLC be and is hereby assessed a fine in the amount

of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Redneck Yacht Rentals LLC pay the cost of this hearing in the amount of TWO THOUSAND AND NINETY-TWO DOLLARS AND NINETY CENTS (\$2,092.90), in addition to the FIVE THOUSAND DOLLARS (\$5,000.00) fine assessed herein.

The Executive Director presented to the Commission Members an application for license as a salesman for a recreational product(s) dealer that had been received from Outdoor Powerhouse, LLC for Kevin Calmes along with documentation regarding Case Number 11-150 LMA, USM Number 05894-095, United States of America vs Kevin Paul Calmes. After reviewing the documents submitted, a lengthy discussion ensued. At the conclusion of the review and discussion, Commissioner Lane made a motion to grant Kevin Calmes a salesman license. Commissioner Krake seconded this motion.

At this time Counselor LaPeyronnie reported to the Commission Members regarding the Kelley Blue Book Co., Inc. DBA KBB.com versus the Louisiana Motor Vehicle Commission, No. 16-CA-281 in the Louisiana Fifth Circuit Court of Appeals. Counselor LaPeyronnie stated on December 7, 2017, the Louisiana Fifth Circuit Court affirmed the Twenty-Fourth Judicial District Court, Parish of Jefferson, State of Louisiana, No. 740-827, Division "K"'s judgment which affirmed the LMVC's decision entered against Kelly Blue Book Co., Inc.

The Executive Director reported to the Commission Members that the commission staff had received several requests from licensees on how long they have to continue complete the vehicle flood disclosure form, pursuant to the following statutes.

LSA-R.S. 32:1265. Sale of water-damaged vehicles

A. No person shall sell, transfer, or convey any new or used motor vehicle or recreational product to any person without notifying the buyer or receiver of the motor vehicle or recreational product in writing of the extent of any water damage from flooding which occurred to the motor vehicle or recreational product prior to the transaction.

B. If a sale, transfer, or conveyance of a new or used motor vehicle or recreational product occurs in violation of Subsection A of this Section, the person receiving ownership and title to the motor vehicle or recreational product who is not otherwise aware of the damage at the time of the transaction may bring an action to set aside the transaction within one year from the date of the transaction and receive all monies or other property given as consideration for the vehicle less a reasonable assessment for miles drive.

C. For the purposes of this Section, a "water-damaged vehicle" means any motor vehicle or recreational product whose power train, computer, or electrical system has been damaged by flooding.

LSA-R.S. 32:1270.3. Sale of water-damaged marine products

A. No person shall sell, transfer, or convey any new or used marine product to any person without notifying the buyer or receiver of the marine product in writing of the extent of any water damage from flooding which occurred to the marine product prior to the transaction.

B. If a sale, transfer, or conveyance of a new or used marine product occurs in violation of Subsection A of this Section, the person receiving ownership and title to the marine product who is not otherwise aware of the damage at the time of the transaction may bring an action to set aside the transaction within one year from the date of the transaction and receive all monies or other property given as consideration for the marine product less a reasonable assessment for wear and tear.

C. For the purposes of this Section, a "water-damaged marine product" means any marine product whose power train, computer, or electrical system has been damaged by flooding.

LSA-R.S. 32:1270.15. Sale of water-damaged motorcycles or all-terrain vehicles

A. No person shall sell, transfer, or convey any new or used motorcycle or all-terrain vehicle to any person without notifying the buyer or receiver of the motorcycle or all-terrain vehicle in writing of the extent of any water damage from flooding which occurred to the motorcycle or all-terrain vehicle prior to the transaction.

B. If a sale, transfer, or conveyance of a new or used motorcycle or all-terrain vehicle occurs in violation of Subsection A of this Section, the person receiving ownership and title to the motorcycle or all-terrain vehicle who is not otherwise aware of the damage at the time of the transaction may bring an action to set aside the transaction within one year from the date of the transaction and receive all monies or other property given as consideration for the motorcycle or all-terrain vehicle less a reasonable deducton for miles driven.

C. For the purposes of this Section, a "water-damaged motorcycle or all-terrain vehicle" means any motorcycle or all-terrain vehicle whose power train, computer, or electrical system has been damaged by flooding.

LSA-R.S. 32:1270.27. Sale of water-damaged recreational vehicles

A. No person shall sell, transfer, or convey any new or used recreational vehicle to any person without notifying the buyer or receiver of the recreational vehicle in writing of the extent of any water damage from flooding which occurred to the recreational vehicle prior to the transaction.

B. If a sale, transfer, or conveyance of a new or used recreational vehicle occurs in violation of Subsection A of this Section, the person receiving ownership and title to the recreational vehicle who is not otherwise aware of the damage at the time of the transaction may bring an action to set aside the transaction within one year from the date of the transaction and receive all monies or other property given as consideration for the vehicle less a reasonable assessment for miles driven.

C. For the purposes of this Section, a "water-damaged vehicle" means any recreational vehicle whose power train, computer, or electrical system has been damaged by flooding.

The Executive Director stated some of the complaints were that some of the vehicle being sold had not even been made when the recent flooding had occurred. The Executive Director continued stating the Department of Motor Vehicles had their own flood damage statute and disclosure form that had to be submitted when registering a vehicle and it had been explained that the Commission could not comment regarding the Department's requirements. A lengthy discussion ensued regarding Commission statutes, the Commission directed the Executive Director to communicate with the various dealer associations regarding the concerns that had been expressed regarding the statutes.

The Executive Director presented to the Commission Members the 2016 Fiscal Year Audit Report which had been sent to all Commission Members on December 27, 2016 via e-mail from the Louisiana Legislative Auditor.

The Executive Director advised the Commission Members a pre-hearing had been held on November 14, 2016, pursuant to LSA-R.S. 49:961C, regarding 961 Notice #2016-072, L D J Manufacturing, Inc. DBA Thunder Creek Equipment, 1833 Highway 163 Pella, IA 50219, for alleged violations of LSA-R.S. 32:1254.A.(1); LSA-R.S. 32:1261.A.(1)(h); and Louisiana Administrative Code Title 46. Part V. Subpart 1. Chapter 5 Motor Vehicle Salesmen; Dealers; Distributors §513. A. License Prior to Shipment. In attendance representing L D J Manufacturing, Inc. 


