Chairman Krake called to order Hearing #2021-008, Tiger Sanitation Services, L.L.C. DBA Tiger Sanitation for alleged violation of engaging in the business as a motor vehicle lessor in Louisiana without a license issued by the Commission. No one from Tiger Sanitation Services, L.L.C. DBA Tiger Sanitation appeared at the hearing. A court reporter was brought in to record the transcript of the hearing, which will be made a permanent part of the Commission's files. JUDGMENT:

On Monday, July 12, 2021, a hearing on the merits of this cause was had before the Commissioners of the Louisiana Motor Vehicle Commission (the "Commission") and a determination of the Findings of Fact, Conclusions of Law, and Ruling was made by the Commission in an open meeting.

APPEARANCE: Tiger Sanitation Services, L.L.C. DBA Tiger Sanitation, 5255 Airline Highway, Baton Rouge, LA 70805, having been duly cited and served with a Notice of Hearing in this matter was not present;

After hearing the testimony adduced at trial, the receipt of the documentary evidence into the record, and for reasons orally assigned, the Commission makes the following finding of fact and conclusion of law and imposition of penalty:

FINDING OF FACT:

Tiger Sanitation Services L.L.C. has been engaged in the business of leasing trailers in Louisiana without possessing a motor vehicle (trailer) lessor license.

CONCLUSION OF LAW:

Tiger Sanitation Services L.L.C. engaged in the business of leasing motor vehicles (trailers) without the required license in violation of LSA-R.S. 32:1254.A.(10), LSA-R.S. 32:1254.I.(4)(a)(b); and LSA-R.S.32.1261.A.(3)(c).

Considering the forgoing finding of fact and conclusion of law, and pursuant to the authority vested in the Louisiana Motor Vehicle Commission as set forth in La. R.S. 32:1251, et seq.:

IT IS ORDERED, ADJUDGED, AND DECREED that Tiger Sanitation Services L.L.C. be and is hereby assessed a fine in the amount of TWENTY THOUSAND (\$20,000.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that should Tiger Sanitation Services L.L.C. obtain a motor vehicle lessor license from the Commission within thirty (30) days of the date of the signing of this Judgment, the fine of TWENTY THOUSAND (\$20,000.00) DOLLARS shall then be reduced to FIVE THOUSAND (\$5,000.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that should Tiger Sanitation Services L.L.C. not obtain a motor vehicle lessor license from the Commission within thirty (30) days of the date of the signing of this Judgment, in addition to the fine of TWENTY THOUSAND (\$20,000.00) DOLLARS, an additional fine of ONE HUNDRED (\$100.00) DOLLARS per day is assessed commencing November 19, 2019 and shall continue to accrue until such time that Tiger Sanitation Services L.L.C. comes into compliance with the laws and rules administered by the LMVC.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Tiger Sanitation Services L.L.C. is also assessed court costs for the full board hearing of this matter in the amount of ONE THOUSAND SIX HUNDRED AND FIFTY-TWO DOLLARS AND FORTY-FIVE CENTS (\$1,652.45), to be paid to the Louisiana Motor Vehicle Commission.
