The Chairman announced the first order of business would be the rule to show cause why the Commission should not fully impose the civil fine assessed against Suckerpunch Sallys, LLC in B-2009-060 and why Suckerpunch Sallys, LLC does not owe to the Louisiana Motor Vehicle Commission the additional Two Thousand Five Hundred (\$2,500.00) and no/100 Dollars for the civil penalty imposed by the Louisiana Motor Vehicle Commission and for all costs, or any part thereof, for these proceedings, including but not limited to court reporter fees, commission attorney fees, the mileage and per diem of the commissioners of the Louisiana Motor Vehicle Commission and other applicable and reasonable costs. No one from Suckerpunch Sallys, LLC was present after being served. A court reporter was brought in to record the transcript of this hearing, which will be made a permanent part of the Commission's files.

The Chairman announced the second order of business would be Hearing #2013-030, Mark Pedersen Equipment Company, LLC for alleged violations of LSA-R.S.32:1254A(18) & C.(12) Application for license; requirements for licensure; contents; licenses; franchise filings and LSA-R.S.32:1261A.(2)(d) Unauthorized acts. In attendance representing Mark Pedersen Equipment Company, LLC was Mark Pedersen, Owner. A court reporter was brought in to record the transcript of this hearing, which will be made a permanent part of the Commission's files.

At this time a discussion ensued regarding the use of the word "invoice" on websites such as Edmunds, NADA, Kelly's Blue Book, etc. The Executive Director advised it had been suggested the use of the word "invoice" on the home page of these and like websites was for consumer research and not for advertising. The Executive Director stated the commission's current position is that research only sites are not covered by the advertising rules, and as such, invoice use is not prohibited. However, when a dealer is tied into a site that uses invoice, the dealer has violated the invoice rule. Commission Counsel stated some of these websites advertise prearranged pricing and hassle-free buying at participating dealerships or words of similar import. After a brief discussion, Chairman Brandt tabled the issue until July and instructed the staff

to conduct further research and report back to the Commission. Commissioner Hocevar made a motion to reflect the Chairman's suggestion and Commissioner Tarver seconded it.

With regard to old business, the Executive Director reported to the Commission Members regarding persons other than franchised, licensed new motor vehicle dealers performing and getting paid for warranty work. The Executive Director stated correspondence had been sent to all licensed manufacturers or distributors as follows:

"The commission has been asked to investigate a complaint that manufacturers are paying for warranty work performed at unlicensed off-site locations for fleet accounts.

LSA-R.S. 32:1261A.(1)(t) prohibits a manufacturer or distributor to authorize anyone other than a franchised licensed motor vehicle dealer to perform warranty repairs. ¹

This letter is to notify you that the commission intends to investigate this claim and asks for your cooperation in advance. Please provide our agency with the names and addresses of any and all parties in the state of Louisiana whom your company pays for warranty service other than Louisiana motor vehicle dealers.

We look forward to working with you as we investigate this matter."

The Executive Director reported some manufacturers responded they only reimburse their dealers and others supplied a list of names and addresses of parties they are paying warranty reimbursement to that are not franchised licensed dealers. After a lengthy discussion, Chairman Brandt appointed Commissioner Duhon, Commissioner Hocevar, Commissioner Timmons, the Executive Director and Counselor Reggie to a committee to review this issue by meeting with representatives of the manufacturing and distributing industry. Chairman Brandt tabled the topic until such time as the committee is ready to report to the commission its findings and suggestions.

¹§1261. Unauthorized acts

A. It shall be a violation of this Chapter:

(1) For a manufacturer, a distributor, a wholesaler, distributor branch, factory branch, converter or officer, agent, or other representative thereof:

(t) To operate a satellite warranty and repair center, to authorize a person to perform warranty repairs who is not a motor vehicle dealer, or to authorize a motor vehicle dealer to operate a satellite warranty and repair center within the community or territory of a same-line or make motor vehicle dealer. This Subparagraph shall not apply to recreational product manufacturers.
