The Executive Director announced that Counselor McCranie is attending Louisiana Used Motor Vehicle Commission monthly meeting this morning as a topic for discussion on their agenda was the Motor Vehicle Sales Finance Act. The Executive Director stated Counselor McCranie would report to the Commission Members at the next Commission meeting.

The Chairman announced the first order would be Hearing #2013-070, Power Group International, LLC DBA Tomberlin Automotive Group. The Executive Director the Commission staff had received bankruptcy documents from Mike Tomberlin, Owner for Power Group International, LLC DBA Tomberlin Automotive Group. Counselor Gregory suggested the hearing be continued to allow time to properly research the bankruptcy. The Commission agreed to continue the hearing to a future date to allow the time needed.

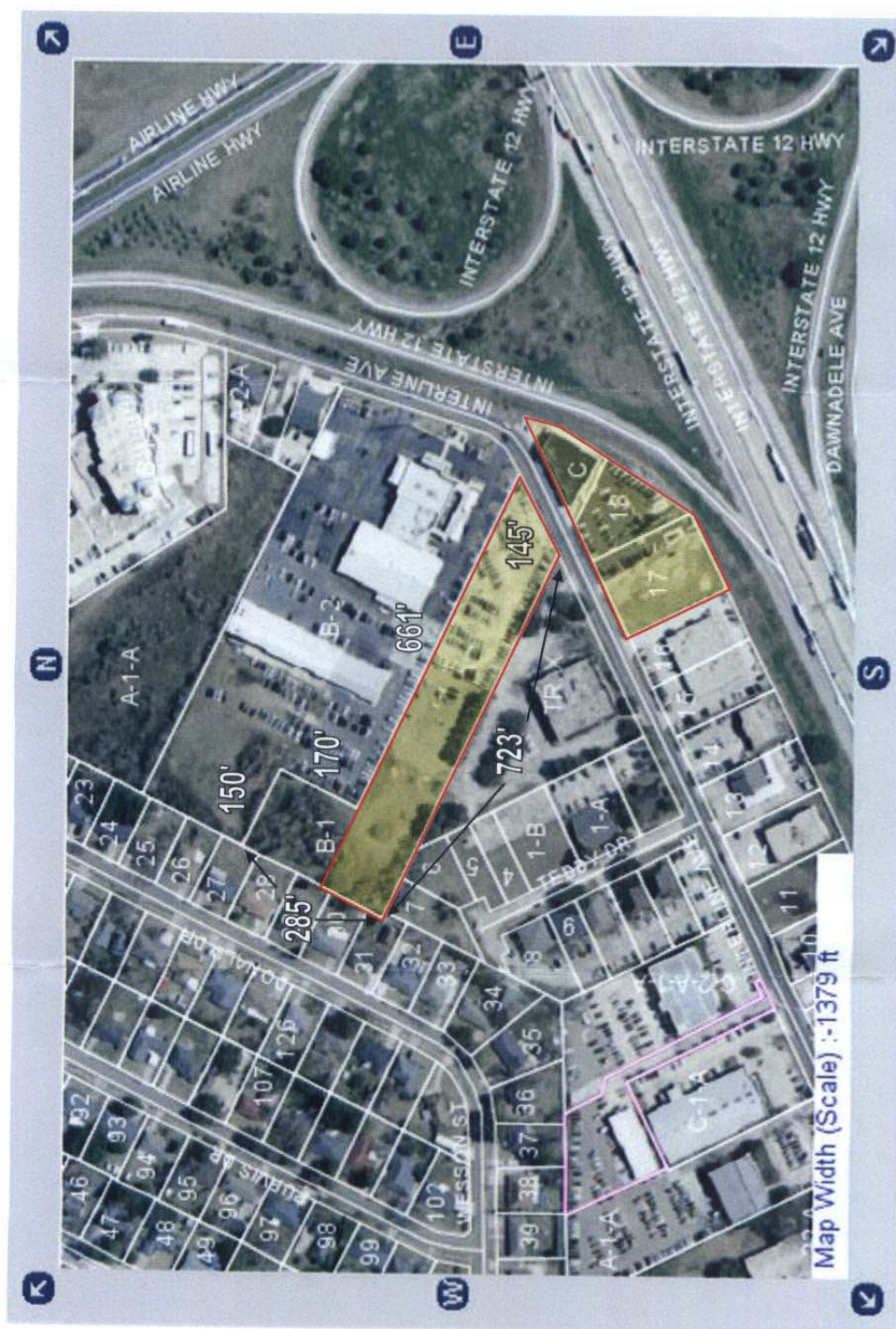
The Executive Director presented to the Commission Members a correspondence from Lance J. Arnold, Attorney for Team Volkswagen, dated November 5, 2013, requesting approval for a possible new dealership location:

"The undersigned represents the Team (Petersen) interests. In connection with an informal discussion following a pre-hearing in the above-referenced matter [Re: Grace-Chenevert Motor Company d/b/a/ Southpoint Volkswagen v. Volkswagen of America, Inc. Louisiana Motor Vehicle Commission, No. 2011-081],

a question arose as to a possible new dealership location which consists of two parcels separated by Interline Ave., Baton Rouge, a typical 25' two lane road with light traffic. An aerial view is attached. Sales and service would be on separate parcels. We request the Board to consider at its next meeting on November 18, 2013 whether the site would comport with regulations as it is separated by Interline.

A brief discussion ensued after the Commission Members reviewed Lance Arnold's request and the map. Commissioner Hargroder made a motion to deny Team's request on the possible new dealership location which was not in compliance with LSA-R.S.32:1254.E.(5) "The applicant must also furnish satisfactory evidence that the applicant maintains adequate space in the building or structure wherein the applicant's established business is conducted for the display of new motor vehicles or recreational products, together with adequate facilities for the repair and servicing of motor vehicles or recreational products and the storage of new parts and accessories for same." Commissioner Corley seconded this motion.

At this time the Executive Director introduced newly hired Commission Investigator Michael Delrie to the Commission Members. The Executive Director asked each of the Commission staff in attendance to introduce themselves to the Commission Members.

Chairman Brant called for an executive session to discuss personnel matters at 10:25 a.m.

11:36 a.m. the Commission meeting resumed.

After a brief discussion, Commissioner Westbrook made a motion to give a 6% increase in salary to L.A. House, Executive Director. Commissioner Timmons seconded this motion and it was unanimously approved.

The Executive Director advised there were two months left in the current year of Counselor LaPeyronnie's two year contract and it would exceed the limits of the contract and requested the following amendment to the contract be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed the maximum amount of \$263,000.00 for the period commencing January 12, 2012 and ending on January 11, 2014." The Executive Director stated the need for the increase in the contract was due to unforeseen legal expenses related to ongoing cases at The US District Court and The Supreme Court of Louisiana and legal expense relative to recreational products licensing and litigations which moved to the Louisiana Motor Vehicle Commission on July 7, 2009 pursuant Act 403 of the 2009 Regular Session of the Louisiana Legislature. After a brief discussion, Commissioner Hicks made a motion to approve the amendment to Counselor LaPeyronnie's current contract. Commissioner Guidry seconded this motion and it was unanimously approved.

The Executive Director continued by stating that Counselor Reggie's two-year legal contract would expire on January 31, 2014 and requested his renewal contracts be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed the maximum amount of \$360,000.00 for the period commencing February 1, 2014 and ending on January 31, 2016."

Additionally, the Executive Director stated Counselor LaPeyronnie's two-year legal contract would also expire on January 11, 2014 and requested his renewal contract be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed the maximum amount of \$240,000.00 for the period commencing January 12, 2014 and ending on January 11, 2016." After a brief discussion, Commissioner LeBlanc made a motion to approve both of the above-mentioned contracts with Counselor Reggie's and Counselor LaPeyronnie. Commissioner Bent seconded this motion and it was unanimously approved.


