The Executive Director presented to the Commission Member the 2014 Fiscal Audit and introduced Michelle H. Cunningham, CPA, of Duplantier, Hrapmann, Hogan & Maher, LLP, who had been assigned to conduct the annual audit of the Commission by the Louisiana Legislative Auditor. Ms. Cunningham outlined the 2014 audit report in detail and responded to the questions posed by the Commission Members.

The Chairman announced the next topic for discussion would be Trapp Chevrolet, 200 South Hollywood Road, Houma, LA and Trapp Cadillac, 1529 Martin Luther King Jr. Blvd. Houma, LA. The Executive Director began by advising the Commission Members staff had been contacted by Barry Songy, Controller for Trapp Cadillac Chevrolet, Inc. inquiring is a separate license would be required as they were in the final stages of renovating their used car building to be their "New Cadillac store". The Executive Director stated the investigation revealed the Chevrolet store is at and faces 200 South Hollywood Road, and the Cadillac store is at and faces 1529 Martin Luther King Jr. Boulevard, in Houma and an application was forwarded to Mr. Songy. The Executive Director continued by stating communication had been had with General Motors explaining a franchise would be needed for the Cadillac store located at 200 South Hollywood Road pursuant to: LSA-R.S. 32:1254 E.(4)(a) Applications for license as motor vehicle and recreational products dealer must, in addition to the foregoing, also be accompanied by the filing with the commission of a bona fide contract or franchise in effect between the applicant and a manufacturer of distributor of the new motor vehicle or vehicles or recreational product or products to be dealt in for a specific location in the state of Louisiana. The Executive Director added there had been advertisement reflecting Trapp Cadillac at the 1529 Martin Luther King Jr. Blvd. Houma location. At this time representatives of General Motors addressed the Commission Members stating Trapp had been on the plot of land for forty years and in 2012 took what had been their used car location and renovated it into a Cadillac showroom which front Martin Luther King Jr. Blvd., however in order for General Motors to issue it a separate franchise there would have to be substantial and costly additions, i.e., parts and service. Mr. Casey added the location was on the facility addendum to the franchise agreement for Trapp Chevrolet Cadillac, Inc., however, the location recognized by General Motors

is 200 South Hollywood Road, where all the business is transacted and all vehicles are invoiced to and delivered. After a lengthy discussion, Commissioner Duhon made a motion based upon the representations made that Trapp Chevrolet Cadillac, Inc. requires only one license at 200 South Hollywood Boulevard in Houma. Commissioner Hicks seconded this motion and it was unanimously approved. The Commission cautioned the representatives for Trapp Chevrolet Cadillac, Inc. that all advertising should reflect only the licensed location 200 South Hollywood Boulevard location.

A court reporter was brought in to record the transcript of the hearing, which will be made a permanent part of the Commission's files. The following Judgment was rendered.

And after hearing the testimony adduced at trial, stipulations made part of the record, the receipt of documentary evidence into the record, and for reasons orally assigned, the Commissioners of the Louisiana Motor Vehicle Commission ("the Commission") make the following finding of facts and conclusions of law:

- Finding of Fact No. 1:**       Ryder Truck Rental, Inc. sold twenty (20) new motor vehicles to Associated Grocers, Inc. without having a new motor vehicle dealer license from the Louisiana Motor Vehicle Commission and/or a franchise from the manufacturer/distributor of those vehicles.
- Finding of Fact No. 2:**       Ryder Truck Rental, Inc. sold one (1) new motor vehicle to Dupuy Storage and Forwarding Corp. without having a new motor vehicle dealer license from the Louisiana Motor Vehicle Commission and/or a franchise from the manufacturer/distributor of that vehicle.
- Conclusion of Law 1:**       Ryder Truck Rental, Inc. committed twenty (20) violations of Louisiana Revised Statute Title 32: Section 1252(35)(a), Section 1254(A)(2), and Section 1261(A)(2)(d) by selling to Associated Grocers twenty (20) new motor vehicles for which it had no license to sell and no franchise with the manufacturer/distributor of those twenty (20) vehicles.
- Conclusion of Law 2:**       Ryder Truck Rental, Inc. committed one (1) violation of Louisiana Revised Statute Title 32: Section 1252(35)(a), Section 1254(A)(2), and Section 1261(A)(2)(d) by selling to Dupuy Storage and Forwarding Corp. one (1) new motor vehicle for which it had no license to sell and no franchise with the manufacturer of that one (1) vehicle.

Considering the forgoing and pursuant to the authority vested in the Louisiana Motor Vehicle Commission set forth in LSA-R.S. 32:1251, et seq.:

**IT IS ORDERED, ADJUDGED AND DECREED** that Ryder Truck Rental, Inc. be and is hereby assessed a fine in the amount of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS for each of the twenty (20) sales of new motor vehicles to Associated Grocers, i.e., \$100,000.00.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** Ryder Truck Rental, Inc. be and is hereby assessed a fine in the amount of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS for the sale of one (1) sale of a new motor vehicle to Dupuy Storage and Forwarding Corp.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that Ryder Truck Rental, Inc. be and is hereby assessed all costs of this matter, including court reporter fees, commission attorney fees, the mileage and per diem of the commissioners and other applicable and reasonable costs as provided for by Louisiana Revised Statute, Title 32, Section 1260(C) in the amount of \$\_\_\_\_\_.

"Schools are constantly seeking dynamic opportunities to support their extracurricular activities and sports programs. As an integral part of the community, Buick would like to help. Building off of its commitment to academic achievement through the Buick Achievers Scholarship Program, Buick is pleased to announce the **Buick Drive For Your Students Program** to provide additional support for student programs withing the community.

Buick will host (sponsored by Barker Buick, Houma, LA) a one day test drive event to raise money for their school. Buick will donate \$10 for every valid test drive taken. If the event exceeds 100 test drives. Buick will double their donation to \$20 per valid test drive. Up to \$10,000 can be raised for the school from a single event!

Upon approval, Buick will activate/staff along with school volunteers the one day event for H.L. Bourgeois High School at #1 Reservation Court, Gray, LA 7035. Local sponsoring Buick dealer Barker Buick - Houma, LA will be limited to provide test drive vehicles/insurance fort the test drive as well as promote the event within the community. H.L. Bourgeois will provide staff volunteers and coordinate activities not limited to the following: Face Painting Booth, DJ Music, Police Demo (car seats), Fire Truck on Site, Ambulance (Acadian), School Mascot, Teams, Band Members, Cheerleaders, and Dance Team.

**IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that TWO THOUSAND FIVE HUNDRED (\$2,500.00) DOLLARS of this fine be suspended conditioned upon Blackwell's Outdoor, Inc., being placed on ONE (1) YEAR probation beginning the date this Consent Judgment is rendered and signed and adhering to all Rules and Regulations of this Commission and Louisiana laws applicable to this Commission during the probationary period. In the event of a violation during the probationary period, the suspended portion of the fine shall become due and payable in full. The type of violation referenced herein does not include any dealer related disputes.




