### APPLICATIONS REVIEWED

<u>Case No. 2013-08-057</u>: Participant is requesting a partial distribution in the amount of \$1,900 of his account balance of \$2,370 for mortgage payments that are in default.

The Hardship Committee approved a partial distribution in the amount of \$900.40 based on documentation submitted from the mortgage company.

<u>Case No. 2013-08-058</u>: Participant is requesting a partial distribution in the amount of \$2,000 of her account balance of \$4,680 for mortgage payments that are in default.

The Hardship Committee approved a partial distribution in the amount of \$2,000 based on documentation submitted from the mortgage company.
