APPLICATIONS REVIEWED

<u>Case No. 17-02-80</u>: Participant is requesting a partial distribution in the amount of \$3,000 of her account balance of \$3,723 for home repairs due to flooding.

The Hardship Committee approved a partial distribution in the amount of \$3,000 based on documentation submitted for property damage from the August 2016 flood.

<u>Case No. 17-02-81</u>: Participant is requesting a partial distribution in the amount of \$7,235 of his account balance of \$29,048 for mortgage payments that are delinquent and medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$6,838.86 based on documentation submitted for mortgage payments and medical expenses.

<u>Case No. 17-01-19</u>: <u>APPEAL:</u> Participant is requesting additional funds in the amount of \$12,000 of her account balance of \$14,569 for medical expenses. Hardship Committee previously approved funds in the amount of \$3,883.99 for mortgage payments that were delinquent and medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$3,225.04 based on documentation submitted for medical expenses.

<u>Case No. 2016-11-307</u>: <u>APPEAL</u>: Participant is requesting additional funds in the amount of \$1,884 of his account balance of \$23,354.42 for legal expenses. Hardship Committee previously approved funds in the amount of \$4,554 for medical and legal expenses.

The Hardship Committee approved a partial distribution in the amount of \$1,884 based on documentation submitted for legal expenses.

<u>Case No. 17-02-82</u>: Participant is requesting a full distribution of her account balance of \$18,070 for loss of wages. Cornelius Keller presented his spouse's case to the committee.

The Hardship Committee approved a full distribution in the amount of \$18,070 based on documentation submitted (tax returns) showing loss of wages.
