<u>Case No. 2016-02-10</u>: Participant is requesting a full distribution of her account balance of \$21,615.62 for removal of home from existing property.

The Hardship Committee approved a partial withdrawal in the amount of \$14,000. Per the plan attorney, funds are eligible under these provisions: The participant isn't buying a home. She currently owns the home. The home is scheduled to be demolished if it isn't moved. It doesn't appear that she has insurance that would cover the costs of moving the home, or other assets that can be liquidated, etc.
