APPLICATIONS REVIEWED

<u>Case No. 17-10-122</u>: Participant is requesting a full distribution of his account balance of \$5,307 for medical expenses.

The Hardship Committee approved a full withdrawal based on documentation submitted for medical expenses.

<u>Case No. 17-10-123</u>: Participant is requesting a partial distribution in the amount of \$2,197.74 of her account balance of \$2,225 for mortgage payments that are delinquent.

The Hardship Committee approved a partial distribution in the amount of \$2,197.74 based on documentation submitted showing mortgage payments are delinquent.

<u>Case No. 17-10-124</u>: Participant is requesting a full distribution of her account balance of \$751.01 to prevent eviction.

The Hardship Committee approved a full withdrawal based on documentation submitted for eviction.

<u>Case No. 17-10-125</u>: Participant is requesting a full distribution of his account balance of \$18,768.99 for home equity line of credit to prevent mortgage from being foreclosed.

The Hardship Committee approved a full withdrawal based on documentation submitted.

<u>Case No. 17-10-126</u>: Participant is requesting a partial distribution in the amount of \$1,028 of her account balance of \$3,244 to prevent eviction.

The Hardship Committee approved a partial distribution in the amount of \$1,028 based on documentation submitted stating participant owes funds to prevent eviction.

<u>Case No. 17-10-127</u>: Participant is requesting a partial distribution in the amount of \$2,035 of his account balance of \$10,254 to prevent eviction.

The Hardship Committee approved a partial distribution in the amount of \$2,035 based on documentation submitted stating participant owes funds to prevent eviction.

<u>Case No. 17-10-128</u>: Participant is requesting a full distribution of her account balance of \$18,709.79 for loss of wages.

The Hardship Committee approved a full withdrawal in the amount of \$18,709.79 based on documentation submitted for loss of wages.

<u>Case No. 17-10-129</u>: Participant is requesting a full distribution of his account balance of \$73,558.14 for medical expenses, loss of wages and mortgage payments that are in foreclosure.

The Hardship Committee approved a partial distribution in the amount of \$13,650.75 based on documentation submitted for medical expenses, loss of wages and mortgage payments.

The Hardship Committee approved a partial distribution in the amount of \$5,500 based on the provisions of the TX-2017-09, Tax Relief for Victims of Hurricane Harvey in Texas, Announcement 2017-11, Relief for Victims of Hurricane Harvey. Participant met the guidelines of living in an affected county.

<u>Case No. 17-10-132</u>: Participant is requesting a partial distribution of \$3,500 of her account balance of \$14,567.12 for damages her stepson received from Hurricane Harvey flooding on August 23, 2017.

The Hardship Committee did not approve a withdrawal at this time. The committee stated the participant's stepson does not qualify under the terms of approval for lineal ascendant or descendant.

<u>Case No. 17-10-133</u>: Participant is requesting a partial distribution of \$5,000 of her account balance of \$9,341.73 for damages she received from Hurricane Harvey flooding on August 23, 2017.

Participant met the guidelines of living in an affected county.

<u>Case No. 17-10-134</u>: Participant is requesting a full distribution of her account balance of \$1,100.31 for damages her son received from Hurricane Harvey flooding on August 23, 2017.

The Hardship Committee approved a full distribution in the amount of \$1,100.31 based on the provisions of the TX-2017-09, Tax Relief for Victims of Hurricane Harvey in Texas, Announcement 2017-11, Relief for Victims of Hurricane Harvey. Participant's son met the guidelines of living in an affected county.
